Subject: 2025 Quality Measurement Program (QMP) Reporting Webinars

Accurate quality measurement data is vital for maintaining care standards and meeting regulatory requirements. All assisted living and residential care facilities, including those with memory care endorsements, must report 2025 quality measurement data between January 1 and 31, 2026.¹

To support accurate reporting, the QMP Program is offering free online webinars for administrators, nurses and leadership responsible for collecting quality measurement data.
