I/DD Medicaid Agencies

Agency certification

Certification type	Fee (initial and renewal)
Medicaid agency certification	\$500 plus endorsement fees

- Renew every 2 years, expiration date is on the agency certification.

Agency endorsements

Endorsement type	Fee (initial and renewal)
24-Hour Residential Services (adult and child)	\$0 (see below for license fees)
Host Homes	\$0 (see below for license fees)
Employment Services	\$100
Supported Living Program	\$100
Community Living Supports – Standard Model Agency	\$100
Community Living Supports – Employer Model Agency	\$100
Direct Nursing Services	\$0 (no fees)
Positive Behavior Support Services	\$0 (no fees)

- Pay endorsement fees when you do agency certification.
- Renew every two years when you renew agency certification.
- Fee is also required if you add endorsements between certifications.

24-Hour Residential license (adult and child)

Application type	Fee
Initial – Clackamas, Multnomah, or Washington county	\$75 per capacity*
Initial – All other counties	\$50 per capacity*
Renewal (all counties)	\$50 per capacity*
Capacity increase (all counties)	\$50 per added capacity*

***Per capacity** means the fee is based on how many people may live in the home. For example, if your capacity is 3 and the fee is \$50, your fee would be 3 x \$50, for a total of \$150.

- Renew every 2 years, expiration date is on the license.

Host Home license

Application type	Fee
Initial	\$0 (no fees)
Renewal	\$50 per home

- Renew every 2 years, expiration date is on the license.

I/DD Foster Homes

Adult Foster Home license

Application type	Fee
Initial – Clackamas, Multnomah, or Washington County	\$75 per capacity*
Initial – All other counties	\$50 per capacity*
Renewal (all counties)	\$50 per capacity*
Capacity increase (all counties)	\$50 per added capacity*

***Per capacity** means the fee is based on how many people may live in the home. For example, if your capacity is 3 and the fee is \$50, your fee would be 3 x \$50, for a total of \$150.

- Renew every year, expiration date is on the license.

Child Foster Home certification

Application type	Fee
Initial and renewal	\$0 (no fees)

- Renew every 2 years, expiration date is on the license.
