Subject: Rever Grand can now accept new referrals

Hello.

I have an update about the provider agency Rever Grand. Please read this message to learn more.

## What happened?

In August 2024, ODDS learned that Rever Grand didn't keep a legal promise from 2019. As a result, ODDS placed something called a "condition of no new enrollments" on Rever Grand. This meant that Rever Grand could not begin working with new clients until they met some expectations. ODDS did not place this condition on Rever Grand because of the credible allegation of Medicaid fraud that the Oregon Health Authority

(OHA) found last year. You can read my update from <u>Dec. 3, 2024</u>, for more details.

As of February 6, 2025, Rever Grand has met the expectations needed to end the "condition of no new enrollments." This means that Rever Grand may now accept new clients again. This does not mean that the Medicaid fraud case against Rever Grand is over. I will continue to send updates about that as we get more information.

## What now?

Your personal agent, services coordinator or case management entity will help you look at all your care choices. They may offer Rever Grand as an option to you. You may choose to begin services with Rever Grand if you decide that is the best choice.
