Public notice on new 1915 (c) Children's Extraordinary Needs Waiver

(Salem, Ore.) — The Office of Developmental Disabilities Services (ODDS) seeks public comment regarding the new 1915 (c) Children's Extraordinary Needs Waiver.

This home and community-based waiver will allow <u>ODDS to implement Senate Bill</u> <u>91</u>. The bill directs ODDS to seek federal approval for a permanent program to pay parents as caregivers. This program is for minor children assessed to have very high medical or behavioral needs.

Summary of proposed waiver

The permanent program will:

- Serve children from birth through age 17 who (1) have significant medical or behavior needs, or a combination of both, and (2) require extraordinary care that is best provided by a legally responsible individual.
 - Children must meet the Intermediate Care Facility for individuals with intellectual disabilities (ICF/IDD), hospital or nursing facility level of care.
- Preserve a family's capacity to care for their child by allowing for legally responsible individuals to provide paid attendant care to their child.
- Assure the health and safety of the child within the family.

 Help children at risk of entering an institution remain in their family home or, if in an institution, to return home.

The services offered include:

- Attendant care provided by a legally responsible individual
- Waiver case management
- Employment Path services
- Supported employment individual employment support and small group employment support
- Discovery career exploration services
- Environmental safety modifications
- Family training conferences and workshops
- Specialized medical supplies
- Vehicle modifications

Service delivery methods include:

- Serving children in their family home.
- Paid care provided by the legally responsible individual hired as a direct support professional employed by an in-home agency.

The full Children's Extraordinary Needs Waiver application is available to <u>read on</u> the ODDS website. Print versions of the waiver amendment proposal and summary are posted in local <u>community developmental disabilities programs</u> and <u>support services brokerages</u>.
