





Who are Mandatory Reporters?

- Physicians, chiropractors, podiatrists naturopaths, interns, physician assistants, residents
- Personal Support Workers, Home Care Workers
- Psychologists, psychiatrists
- Clergy · Attorneys .Dentists
- Speech, physical & occupational therapists
- Info & referral, crisis, outreach workers

- Legislature members
- DHS/OHA personnel
- County staff health, mental health, developmental disabilities programs
- AAA Services
- Senior center employees
- Family/guardians/legal counsel of nursing facility residents
- Adult foster home licensees
- •CCA employees

- Licensed Nurses (RN and LPN)
- CNAs, CMAs, home health employees, nurse practitioners
- Regulated social workers, licensed counselors and marriage and family therapists
- Peace officers, Firefighters, Emergency Medical Technicians

What does mandatory reporter mean?



Mandatory reporters have to report suspected abuse immediately for:

✓ Children – 24/7
✓ Adults 65 or older – 24/7

While "on duty" for people experiencing:

Mental Illness or Intellectual/Developmental Disabilities

What if a mandatory reporter...

...fails to report?

Possibilities:

- > Loss of professional license
- Loss of ability to work within Medicaid services
- > Possible legal penalties



- Memory
- Physical challenges
- Decline in overall health
- Chronic health concerns

Vulnerability and Risk

- Social isolation
- Dependency on others
- Living with others
- No family close by
- Few close, long-term relationships
- Little community support

Vulnerability and Risk



- Housekeeping needs
- Home repair needs
- Upgrades in technology

What is Abuse?



There are 8 types for older adults plus, Self-Neglect

Types of Abuse: Physical Abuse




- Using physical force that may cause pain or harm
- A physical injury that is not an accident

Types of Abuse: Neglect



Not providing basic care or health and safety to a vulnerable person when there is a responsibility to do so.

Types of Abuse: Abandonment



Deserting a person whom you agreed to provide care:

- resulting in a harm
- or risk of serious harm

Types of Abuse: Verbal or Emotional



Written, spoken, or gestured, directed to the vulnerable person causing significant anguish or distress

Types of Abuse: Financial Exploitation




Taking money, things, or property without permission

Taking a person's medication

Spending money on things that are not for person's benefit

Types of Abuse: Sexual Abuse



Unwanted sexual contact

Sexual harassment

Any sexual crime

Sexual contact with a paid provider unless the two are spouses

Types of Abuse: Involuntary Seclusion



Someone is restricting:

- contact or activities with family or friends
- ➢ phone, mail, email
- person limited area of the house

Types of Abuse: Physical or Chemical Restraint

- Tying a person to a chair or bed
- Using medication to get person to sleep for the convenience of the caregiver



Types of Abuse: Self-Neglect




does <u>not</u> involve wrongdoing


does involve harm or risk of harm.

- Personal stress
- Severe external stress
- Financial stress

Caregiver has:

- Personal/financial stress
- Lives with the victim
- Depends on the victim

What do I say when I call?



- Where event happened
- What you saw or heard
- Name of possible abuser
- Your contact information
- You can remain anonymous
 - You can ask to be kept in the loop
