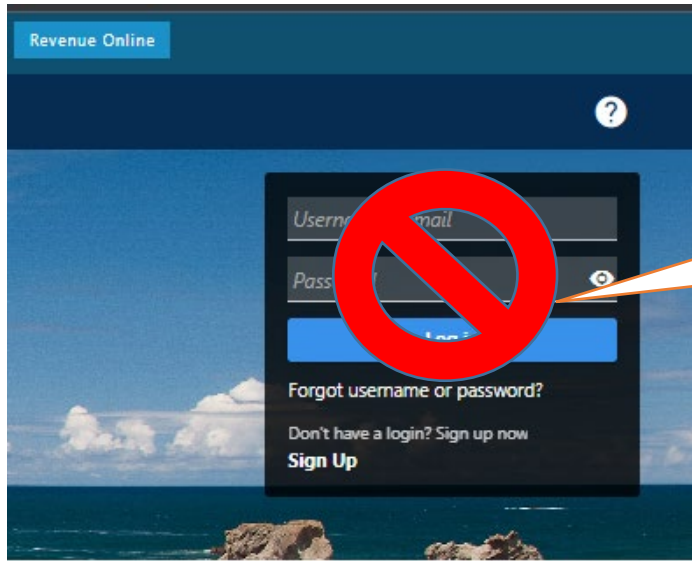

How to defer property tax payments

About tax deferral

State residents who are disabled or senior homeowners may qualify for Oregon's tax deferral program if eligible and borrow from the State of Oregon to pay their county property taxes. Qualified homeowners repay the loan amounts with 6% interest.

Apply or recertify

- [Application—Oregon Senior and Disabled Citizen Property Tax Deferral](#) 150-490-014. Application to be filed with county assessor's office.
- Recertification for the deferral program is required every two years. The Department of Revenue will mail out a recertification letter to you when you are required to recertify. This letter is mailed in February. You may recertify through [Revenue Online](#) using the letter ID number from the recertification letter OR you can fill out the paper copy and return it to the department at the address included with your letter.
