Overview: This Worker Guide policy is for all CDDP staff who complete eligibility tasks related to eligibility determination notices.

Description: The Eligibility Determination Worker Guide provides instruction for required decision notices:

- Notice of Presumptive Eligibility (<u>DE 80650</u>)
- Notice of Eligibility Determination (<u>SDS 5103</u>)
- Notice of Redetermination (DHS 5101)
- Notification of Planned Action (NOPA) (SDS 0947)

Purpose/Rationale: The Office of Developmental Disabilities Services (ODDS) recommends that you use the language in this guide as a foundation for completing the Notice of Presumptive Eligibility (DE 80650),

Notice of Eligibility Determination (<u>SDS 5103</u>), Notice of Redetermination (<u>DHS 5101</u>), and the Notification of Planned Action (NOPA) (<u>SDS 0947</u>).

As appropriate, add specific details in the "Reason for Action" that are relevant to the Oregon Administrative Rule (OAR) you cite in the NOPA. Use your professional judgment to add or subtract from the recommended language below to make the decision notice simple, clear and specific to the individual's eligibility determination.

Applicability: This applies to CDDPs; specifically, eligibility specialists and CDDP staff assisting eligibility specialist with eligibility administrative tasks.

Procedures that apply:

Notice timeline:

All decision notices must be sent within 10 business days of a completed application per OAR 411-320-0080(13), and include specific rules based on the individual determination.

Notice procedures:

The Notice Writing table at the end of this guide includes OAR citations of all applicable OARs required for specific eligibility scenarios and recommended language for all notices.

OAR Citation:

Abbreviated citations are appropriate and acceptable in some cases. If you use shortened citations, you must remember to include the word 'and' or '&' in between each section, subsection, paragraph or subparagraph.

Example: OAR '411-320-00080(9)(a)(A); 411-320-0080(9)(a)(B)'. Instead, you could list it as OAR 411-320-0080(9)(a)(A) and (B).

411= is the chapter	(8) = is the section	(A) = is the paragraph

Delegation of Authority:

Include OARs 943-001-0020(3), 410-120-0006 and 411-320-0080(2) on all NOPAs and Eligibility Determination Notices.

OAR 943-001-0020(3) and 410-120-0006 explain shared delegation and responsibilities between the Oregon Health Authority and the Department of Human Services for Medicaid eligibility determinations. OAR 411-320-0080(2) identifies that the CDDP eligibility specialists are acting as a

designee of the Department of Human Services.

Records obtained in the eligibility determination process must be listed on notices.

Example: You received medical records, but they were not used in the determination. You still need to list them as records that were reviewed on the notice. If you have a specific report that was used for the eligibility determination, you will need to list that specific report. List as:

Documentation of determination notice: All determinations must be:

- Documented in a progress note following OAR 411-320-0080(13);
- Attached in eXPRS eligibility line; and
- A copy of all notices must be kept in the CDDP file.
