**Email:** Clarification - Program Changes in Mainframe and PTC

Date Sent: 5/6/25

Program changes must never be backdated without help from PTC Support. This email clarifies instruction previously given about what to do when a consumer changes programs. Topics include:

- Updates to the program change process,
- Instructions to Case Managers and Voucher Specialists on their role in program changes,
- Steps to take when a program change does not need to be backdated, and
- What to do if you need further assistance.

**Email:** *Important Mainframe Updates* 

Date Sent: 6/13/25

Mainframe has implemented several changes to screens related to provider payment.

- 1. Mainframe can now process mileage entered in decimal format.
- 2. ONGO will automatically close when there has been no time entered for three pay periods, or it has been more than six weeks since a voucher was created and no time has been entered against it.
- 3. The HATH screen has been simplified to remove codes that do not apply and fields that are no longer valid.
- 4. Hours on the STIM screen will be shown in HH:MM format, instead of HH.MM.
