## Policy updates, rule clarifications and announcements

To: APD Adult Foster Home Providers

**Topic:** Update on Vaccine Coordination for Adult Foster Homes

The Oregon Department of Human Services sent notification in October that Adult Foster Homes (AFH) licensed by the Office of Aging and People with Disabilities could participate in the Federal Pharmacy Partnership for Long-Term Care Program for no-cost COVID-19 vaccinations. This partnership is being led by the Centers for Disease Control (CDC) and includes nationwide pharmacy partners.

AFH licensees that did not enroll are still able to receive vaccine support. The Department has given the list of facilities not enrolled to Oregon's Local Public Health Authorities (LPHAs) and Coordinated Care Organizations (CCOs) and have asked them to connect and support vaccination services for AFHs in their area. We are also working with each LPHA and CCO to assess where additional support is needed from the state. This effort includes working with each LPHA to identify if there are alternate solutions to support AFH providers in receiving COVID-19 vaccines in a timely manner. Please accept phone calls and emails from LPHAs, District Managers or CCOs who may be in touch to assess your vaccine needs.

Everyone involved is dedicated to ensuring as many individuals can be vaccinated as quickly as possible, making sure Oregonians in long-term care are prioritized. Vaccine schedules are coordinated to most efficiently distribute the vaccine doses available.

We all feel a high degree of urgency to make vaccines available to you. We will continue to offer updates as more information is available. In the meantime, if you have not heard from an LPHA or CCO and are not signed up to receive

COVID-19 vaccine support, the Department will be contacting you in an effort to help to make the necessary connections.

We have also shared this information with ODHS District Managers and offices so they can help navigate vaccine connections to vaccine opportunities.
