Effective 09/01/2020, AllCare PACE, LLC (provider number **500781098**) is approved to provide PACE services to individuals in parts of Jackson and Josephine counties.

AllCare PACE will serve individuals who:

- Meet the PACE Eligibility Criteria;
- Are eligible for long-term services and supports (LTSS); and
- Are dually eligible for Medicaid and Medicare.

PACE provides comprehensive LTSS and health services in a coordinated manner. PACE providers receive a capitated payment each month for each enrolled Medicaid participant and take on the entire risk of serving eligible individuals. AllCare PACE is different than a CCO and is a service option for LTSS that should be discussed with eligible individuals.

As a reminder, a brochure was developed for individuals to learn more about PACE. It is form DHS 2658 and is available in multiple languages. The brochure is available on the forms server and can be ordered through FBOS.
