Training becomes mandatory for all homecare and personal support workers and personal care attendants on Sept. 1, 2021 and will be provided by our partner, Carewell SEIU 503 Training. Carewell is a partnership between the State of Oregon and SEIU 503 and was created alongside the passing of SB 1534. Their mission is to deliver quality training to homecare and personal support workers and personal care attendants.

Carewell SEIU 503 Training launched a statewide pilot on Dec.1, 2020 for the New Worker Training series. This includes:

- Orientation (4 hours online) available on demand
- Online Core (4 hours of self-paced online modules) available on demand
- Core Workshop (a 4-hour instructor-led webinar) available several days and times per week, including evenings and weekends

Training is available in English, Spanish, Russian, Vietnamese, Arabic, and Simplified

Chinese (voiceovers in Mandarin). Interpreter services are provided when requested.

Orientation is designed to be taken when an individual applies to be a worker (preenrollment). After a newly enrolled worker completes orientation, they will be directed by Carewell to complete Online Core and the Core Workshop within 120 days of enrolling as a homecare worker, personal support worker, or personal care attendant.

Workers hired during the pilot period and who complete the New Worker Training series will not need to take the refresher training for the current workforce when it becomes a requirement in 2021. Information about refresher training will soon be available.
