Core Case Management – An Introduction

Virtual Training, 3 Days for 3 hours each day

This introduction to Case Management and is intended for new APD/AAA Medicaid Case Managers who have been in their positions for six months or less, preferably taken within the first two months after hire, prior to taking Assessing and Determining SPLs.

The course will help Case Managers become familiar with the programs and services Medicaid Long Term Services and Supports offers.

Topics include: CM Roles and Responsibilities, Case Manager Safety in the Field, Narration, In-Home Programs, Facility Types, K-Plan Ancillary, Spousal Pay, Exceptions, Natural Supports, Adult Protective Services, and Preventing Fraud.

Topics include: Service Priority Levels, General Assessment Information, Service Eligibility Drivers, Methods of Assessing, Thorough Review of every ADL and how to Assess, How to Determine Appropriate Assist Level for each Component / ADL, Writing Strong Comments to Support Decisions, and Understanding Cognition
