This IM has been updated to inform staff that Module 2: Financial Role and Policy and Module 3: Eligibility Criteria (Service and Financial) Part 1 & 2 have been released.

Message:

Aging and People with Disabilities (APD) has developed a new program: Oregon Project Independence – Medicaid (OPI-M). This program has been approved by CMS and will begin a statewide rolling implementation June 1, 2024. The details of the rolling implementation will be provided in separate communications.

OPI-M is an in-home only program that serves adults with primarily physical disabilities between the ages of 18-59 or all adults who are 60 or older.

The basic eligibility requirements include:

- Income at or below 400% Federal Poverty Level (FPL).
- Resources at or below the average cost of six months in a nursing facility.
- An assessment resulting in a Service Priority Level between 1-18.

A few of the features for OPI-M include:

- Waiving estate claims while on OPI-M.
- In-home service hours, up to 40 hours per pay period, determined through personcentered practices.
- A variety of different service options to support an individual in their home.
- Individuals having the ability to retain or apply for Medicaid medical benefits.

Under the <u>OPI-M section</u> on the CM Tools page, review the <u>Service Program Options Comparison Chart</u> to understand the differences between OPI-M and other similar programs offered by APD and Area Agencies on Aging (AAA) offices.

Module 1 provides additional information on case management related tasks to help administer the OPI-M program.

Module 2 explains who determines financial eligibility, financial policy, and service requests.

Module 3 gives details and information on service and financial eligibility.

Training is available for all staff who engage with individuals interested in or currently receiving services through APD and AAAs. This includes but is not limited to case managers (CM), eligibility workers, Aging and Disability Resource Connection (ADRC) staff, and support staff.
