### **Oregon ACCESS End of Year Updates**

#### **COLA Overview**

In the past, as part of the End of Year process, the income types in Oregon ACCESS that are administered by the Social Security Administration were updated with the Cost-of-Living Adjustment. This process is being discontinued, beginning in 2023. Staff will need to manually update those income types for consumers whose financial records are not managed in the ONE system.

#### **OSIPM Standard Update**

The OSIPM Standards and Community Spouse Allowance will change effective 01/01/2024. Oregon ACCESS will update these amounts the night of 12/26/2023.
