Oregon Transportation Infrastructure Bank Highlighted Projects

<u>City of Madras and Jefferson County – J Street Bridge Floodplain Mitigation</u> Loan Amounts – each Ioan was \$2,233,420

The J Street and City View Street expansion project was a joint project between Jefferson County and the City of Madras. Constructed in 2005, the project included an extension of City View Street and J Street; a roundabout intersection; a bridge over Willow Creek; and several utilities. In the early 2000's, fill was placed in



solution to mitigate the issue. The firm came up with two alternatives (build a levee or expand the bridge). After consideration by the Jefferson County Board of County Commissioners and City, it was determined that expanding the bridge was the best option to mitigate the 100-year floodplain impact issue.

This project expanded the Willow Creek Bridge to

the future J Street roadway to create a subgrade and to build-up embankments for a future bridge over Willow Creek. This fill created a flow restriction of the 100-year floodplain area and affected other properties not originally within the 100-year floodplain impact area. The road fill placement occurred prior to the actual roadway and bridge construction.

It was not until the City completed an update to its FEMA floodway mapping that discovery occurred of road fill and bridge improvements restricting floodplain flows that caused storm water to back up and flood neighboring properties. The City then hired an engineering firm to complete a feasibility and alternative analysis to determine the most cost-effective



the west 160 feet. The model analysis showed that an additional span of approximately 160-ft was required to pass the storm water flow to create a no rise condition downstream/upstream of the bridge and mitigate the flooding issue created by installation of the bridge and associated road fill. This project included land acquisition and all the necessary environmental permitting to work in Willow Creek. Other work included grading, walking path relocation, and engineered berm with flow control structure. The flow control structure only allows flow from west to east to protect other properties outside the 100-year floodplain area.

The project costs were split equally between Jefferson County and the City of Madras. Madras was the lead on the project including all the permitting, engineering, construction, and floodplain map updating.

Belle Mer Sigl Tract Special Road District – Road Repair and Maintenance

Loan Amount - \$85,000

As this was a fairly small project the work was able to be completed and the loan fully disbursed within five weeks of execution.

A tax levy was passed for Belle Mer Sigl Tract Special Road District in Lincoln County, near Depoe Bay to receive approximately \$26,000 per year for road maintenance and repair. The OTIB loan allowed Belle Mer Sigl Tract Special Road District to do needed maintenance and repairs on their roads immediately to eliminate further damage and additional costs.

resurfaced roads, sealed cracks, and strategically placed replacement asphalt in two high-traffic zones. Perhaps most importantly, our roads are now adorned with clear and highly visible markings, including fire lanes, crosswalks, and speed bumps. This enhanced visibility contributes significantly to the safety of our residents, particularly during nighttime hours."

<u>City of Molalla – OR 213 at Toliver Road Intersection Improvement Project</u> Loan Amount –\$2,500,000

This OTIB loan was established for an intersection improvement project at OR 213 and Toliver Road.

OR 213, is a part of the state highway system under the jurisdiction and control of the Oregon Department of Transportation ("ODOT"). Toliver Road is a city street under the jurisdiction and control of the City of Molalla. Molalla adopted a new Transportation System Plan and a Comprehensive Plan Amendment with a condition of

approval regarding this intersection. Molalla received an application from a developer to develop a large parcel of land near the intersection, and as a condition of the zone change and Comprehensive Plan Amendment becoming effective, Molalla was required to establish and adopt a funding mechanism for improvements at this intersection.

ODOT conducted a Road Safety Audit ("RSA") of the intersection to outline existing intersection issues and provide



suggestions for the best solution. ODOT subsequently conducted an Intersection Control Evaluation ("ICE") to consider multiple context-sensitive control strategies for the modified intersection. The ICE indicated that a



roundabout could provide adequate capacity and minimize delay under 2040 traffic conditions, accommodate freight movements, and accommodate bicycle and pedestrian users with significant safety benefits as compared to other alternatives. As a result of the RSA and the ICE, ODOT moved forward with constructing a roundabout at the Intersection to achieve safe and efficient operations of the highway.

The original loans were for a phase of the much larger Newberg/Dundee Bypass project. Looking forward to funding future phases on the bypass project there was interest in obtaining new loans to provide the needed funds for the next phases. The problem was that was the jurisdictions wished to maintain the same annual payment amounts as their original loans. That would not have been possible if new loans were established so the consensus was to refinance the original loan, adding additional capacity to draw funds as needed for future phases, but maintain the same annual payment. As the phases will take many years to complete the final draw will be no earlier than 30 years before the final maturity date of the loans.

Summary of OTIB Operations for Federal Fiscal Year 2023

<u>Funds</u>

The OTIB ended federal fiscal year (FFY) 2023 with a cash balance of \$24,711,562. Currently the cash balance consists of funds contained in six accounts:

• 641-01 Administrative / State Highway Fund Account:

Balance: \$636,571

- **Description:** This account is capitalized from loan origination fees and other revenues such as late payment charges. The purpose of this account is to pay administrative expenses, such as Department of Justice fees, and direct staff charges. These funds carry Oregon constitutional and statutory restrictions.
- 645-01 SIB Highway Account:

Balance: \$5,675,923

- **Description:** The purpose of this account is to originate loans for U.S.C. Title 23 Highways and U.S.C. Title 49 Transportation purposes. It was capitalized by an original federal SIB appropriation and matched with State Highway Fund monies. These funds can be used for loans for Title 23 and Title 49 purposes and carry federalization requirements.
- 645-02 SIB Transit Account:

Balance: \$7

- **Description:** The purpose of this account was to originate loans for public transportation projects that are federal aid eligible. It was primarily capitalized through monies received via the "Stripper Well" settlement and matched with other federal disbursements. Those funds carried federalization requirements and have been fully expended. The account will be rebalanced to \$0 in 2024, and the remaining \$7 is attributed to marginal interest earnings.
- 645-03 SIB Transit Repayment Account:

Balance: \$2,994,495

- **Description:** This account is capitalized from repayments for loans made from the 645-02 Transit Account, which are from non-federal sources. These funds can be used for loans for public transportation projects that are federal aid eligible. Because of the unique circumstances related to the status of the OTIB as a pilot SIB, repayments from the original recapitalization that are from non-federal sources are not subject to full federalization requirements when loaned back out (i.e., recycled).
- 645-04 State Highway Fund Account:

Balance: \$7,071,004

Description: The purpose of this account is to originate loans for road and highway projects. This account was capitalized primarily through a transfer of State Highway Fund monies. These funds carry Oregon constitutional and statutory restrictions.

- 645-05 SIB Highway Repayment Account:
 - Balance: \$8,333,561
 - **Description:** This account is capitalized from non-federal sourced repayments for loans made from the 645-01 SIB account. The purpose of this account is to originate loans for Title 23 and Title 49 purposes. Repayments from the original recapitalization that are from non-federal sources are not subject to full federalization requirements when loaned back out.

FFY 2023 Loans

From its inception to September 30, 2023, OTIB has originated a total of 58 loans. OTIB has 27 loans with an outstanding balance of \$19,930,520.43 in its Active Portfolio, and an additional \$32,754,555.12 is obligated to borrowers, but has yet to be drawn upon. The remaining 31 loans totaling \$54,685,029 are fully repaid. The average loan size is \$2,206,835.

OTIB originated two loans in Federal Fiscal Year 2023:

- Sunset Empire Transportation District
- Belle Mer Sigl Tract Special Road District, Road Repair and Maintenance

OTIB originated four refinances in 2023.

- City of Dundee, Newberg-Dundee Bypass Phase 2 and 3
- City of McMinnville, Newberg-Dundee Bypass Phase 2 and 3
- Yamhill County, Newberg-Dundee Bypass Phase 2 and 3
- City of Newberg, Newberg-Dundee Bypass Phase 2 and 3


