### Introduction



# **Oregon Transportation Infrastructure Bank Highlighted Projects**


# <u>City of Coburg – Street Repair and Maintenance Project</u> Loan Amount – \$999,500



At the time the City of Coburg applied for this OTIB loan Coburg's street network included streets in different stages of disrepair, including complete reconstruction, 2 inch overlay, crack seals and slurry seals. Most of those projects were on local streets. However, one of the largest projects was on a collector street in Coburg's industrial area where there is significant daily utilization of the road by heavy trucks.

Coburg's plan was to intentionally balance the reconstruction of their worst streets with the preventative treatments of their best streets to avoid falling farther behind in their plan to restore their streets to acceptable Pavement Condition Index.

"The Roberts Road and Roberts Court project was the first project in Coburg funded with the City's new Transportation Utility Fee that was well over a year in development with community outreach, many Council meetings and significant expectations of the funding translating quickly to projects on the ground. Roberts Road and Roberts Court are important transportation assets as they both serve a high number of light industrial and heavy industry supporting businesses that operate throughout the region. Ensuring high quality infrastructure to the City's light industrial base is important to the success of the city and contributes to the success of the region." Adam Hanks, City Administrator




# <u>City of Medford – Foothill Road Project</u> Loan Amount – \$10,000,000

The Foothill Road Improvement project is a modernization and safety project which widens two miles of Foothill Road between Hillcrest Road and Delta Waters Road in East Medford. Widening Foothill Road, a major arterial, to five travel lanes, with a center turn lane, curb, gutter, sidewalk and bike lanes. The improvements to the narrow, unsafe, two-lane roadway will assist with eliminating poor sight distance, over capacity volumes and large volumes of crashes.

The project was designed by the City of Medford, and the construction contract is being managed by the Oregon Department of Transportation (ODOT). Construction started in February 2023 with an anticipated completion date of September 2026. The total construction cost for the project is \$56.4M and is funded with a variety of funding sources including \$15.5M from a Federal BUILD grant; \$10M loan from OTIB; \$3M Congestion Mitigation & Air Quality Improvement Program; Rogue Valley Metropolitan Planning Organization; and City of Medford funds.





"Improving Foothill Road has been a priority for the City of Medford for several decades as this narrow, two-lane, unsafe facility had long outlived its useful life," said John Vial, Medford Public Works Director. Vial added, "Funding major projects like this often requires cobbling together funds from multiple sources and OTIB Program was essential in assisting financing of this project for the City."

"The partnership we've experienced with ODOT Region 3 staff on this project has been outstanding," noted Dennis Hart, Medford's Design Section Manager. Hart added, "ODOT was great in helping with the design the project and now they are delivering the project's construction with a hybrid inspection team of ODOT and City of Medford project inspectors, a true example of collaboration."

# <u>City of Dundee – 9<sup>th</sup> Street Improvement Project</u> Loan Amount - \$1,387,433




The City of Dundee is experiencing significant growth and refocusing their efforts to attract visitors to the Willamette Valley and particularly to Yamhill County. A way to accomplish this was to upgrade SW 9<sup>th</sup> Street in Dundee and make it an entrance way into Willamette Wine Country.

SW 9<sup>th</sup> Street was a two-lane collector road that had not been updated for many years.

There was an old broken sidewalk on the west side of the road, multiple potholes, along with cracking asphalt all the way up and down the road, an old water line that needed to be replaced and the city had to locate some utility lines underground.



# <u>City of Dundee – 9<sup>th</sup> Street Improvement Project Continued</u>



The city borrowed \$1,387,433 from OTIB and matched it with \$1,700,00 from the city's urban renewal agency to rebuild the street. The project consisted of ungrounding utilities and conduit, replacing a water line, repaving, and installing sidewalks and crossing locations on both sides of the street. With newly planted trees, the City hopes this welcoming roadway will make for an impressive drive into the area's internationally known wineries.



## **Summary of OTIB Operations for Federal Fiscal Year 2024**

#### **Funds**

The OTIB ended federal fiscal year (FFY) 2024 with a cash balance of \$27,102,741. Currently the cash balance consists of funds contained in six accounts:

641-01 Administrative / State Highway Fund Account:

**Balance:** \$1,471,886

**Description:** This account is capitalized from loan origination fees and other revenues such as

late payment charges. The purpose of this account is to pay administrative expenses, such as Department of Justice fees, and direct staff charges. These

funds carry Oregon constitutional and statutory restrictions.

645-01 SIB Highway Account:

**Balance:** \$5,515,877

Description: The purpose of this account is to originate loans for U.S.C. Title 23 - Highways and

U.S.C. Title 49 - Transportation purposes. It was capitalized by an original federal SIB appropriation and matched with State Highway Fund monies. These funds can be used for loans for Title 23 and Title 49 purposes and carry federalization

requirements.

645-02 SIB Transit Account:

Balance: \$0

**Description:** The purpose of this account was to originate loans for public transportation

projects that are federal aid eligible. It was primarily capitalized through monies received via the "Stripper Well" settlement and matched with other federal disbursements. Those funds carried federalization requirements and have been

fully expended.

• 645-03 SIB Transit Repayment Account:

**Balance:** \$3,572,839

**Description:** This account is capitalized from repayments for loans made from the 645-02

Transit Account, which are from non-federal sources. These funds can be used for loans for public transportation projects that are federal aid eligible. Because of the unique circumstances related to the status of the OTIB as a pilot SIB, repayments from the original recapitalization that are from non-federal sources are not subject to full federalization requirements when loaned back out (i.e.,

recycled).

#### • 645-04 State Highway Fund Account:

**Balance:** \$6,608,141

**Description:** The purpose of this account is to originate loans for road and highway projects.

This account was capitalized primarily through a transfer of State Highway Fund monies. These funds carry Oregon constitutional and statutory restrictions.

#### • 645-05 SIB Highway Repayment Account:

**Balance:** \$9,933,998

**Description:** This account is capitalized from non-federal sourced repayments for loans made

from the 645-01 SIB account. The purpose of this account is to originate loans for Title 23 and Title 49 purposes. Repayments from the original recapitalization that are from non-federal sources are not subject to full federalization requirements

when loaned back out.

#### FFY 2024 Loans

From its inception to September 30, 2024, OTIB has originated a total of 61 loans. OTIB has 30 active loans with an outstanding principal balance of \$20,076,104.54, and an additional \$32,665,615.03 is obligated to borrowers, but has yet to be drawn upon. The remaining 31 loans totaling \$54,685,029 are fully repaid. The average loan size is \$1,965,757.


OTIB originated two loans in Federal Fiscal Year 2024:
