Introduction

This year a major focus of the Oregon Transportation Infrastructure Bank (OTIB) was getting the word out about OTIB and that there is money available to loan. This included participation in Business Oregon's One-Stop Financing Roundtables; exhibit tables at the League of Oregon Cities and the Association of Oregon Counties Annual Conferences; and speaking at the MPACT Transit + Community Conference in Portland.



The 2025 Oregon Transportation Infrastructure Bank Annual Report highlights the City of Sherwood's Ice Age Drive project. A key piece of funding that made this project possible was a \$5 million loan OTIB. Other funds included a Special Public Works Fund Loan, committed Federal Highway Administration funds, and local funds. OTIB was brought in as one of the sources by being invited to a Business Oregon One-Stop Financing Roundtable. Oregon Transportation Infrastructure Bank Highlighted Project

City of Sherwood – Ice Age Drive

Loan Amount – \$5,000,000

Sherwood's Ice Age Drive project—aptly titled “Moving Boulders to Create Jobs Land”—is a major infrastructure investment intended to unlock approximately 300 acres of employment-designated land and support long-term economic development in the city.

Sherwood, with a population of 20,868 as of 2023, is located roughly 13 miles



southwest of downtown Portland and has historically functioned as a bedroom community within the region. In recent years, however, the city has experienced rapid growth in its employment base, driving the need for infrastructure investments that support job creation closer to where residents live.

The Ice Age Drive project includes construction of a three-lane collector roadway within the City of Sherwood and is financed through a combination of state, federal, and local funding sources.

Total project costs are estimated at approximately \$16 million and include design and engineering, roadway construction, construction contingency, land acquisition, construction management, and gas line relocation.

Upon completion, Ice Age Drive will provide the infrastructure needed to overcome existing site constraints, reduce commuting pressures, and position Sherwood to continue its transition from a bedroom community to a more balanced city with a growing, resilient employment base.

Summary of OTIB Operations for Federal Fiscal Year 2025

Funds

The OTIB ended federal fiscal year (FFY) 2025 with a cash balance of \$29,525,275. The cash balance consists of funds contained in six accounts:

- **641-01 -- Administrative Fund Account:**

Balance: \$2,129,064

Description: This account is capitalized by loan origination fees and other revenues such as late payment charges. The purpose of this account is to pay administrative expenses, such as Department of Justice fees, and direct staff charges. These funds carry Oregon constitutional and statutory restrictions.

- **645-01 SIB -- Highway Account:**

Balance: \$5,783,842

Description: The purpose of this account is to originate loans for U.S.C. Title 23 - Highways and U.S.C. Title 49 - Transportation purposes. It was capitalized by an original federal SIB appropriation and matched with State Highway Fund monies. These funds can be used for loans for Title 23 and Title 49 purposes and carry federalization requirements.

- **645-02 -- SIB Transit Account:**

Balance: \$0

Description: The purpose of this account was to originate loans for public transportation projects that are federal aid eligible. It was primarily capitalized through monies received via the “Stripper Well” settlement and matched with other federal disbursements. Those funds carried federalization requirements and have been fully expended.

- **645-03 -- SIB Transit Repayment Account:**

Balance: \$3,892,033

Description: This account is capitalized by repayments for loans made from this account and the 645-02 Transit Account, which are made from non-federal sources. These funds can be used for loans for public transportation projects that are federal aid eligible. Because of the unique circumstances related to the status of the OTIB as a pilot SIB, repayments from the original recapitalization that are from non-federal sources are not subject to full federalization requirements when loaned back out (i.e., recycled).

- **645-04 -- State Highway Fund Account:**

Balance: \$7,303,985

Description: The purpose of this account is to originate loans for road and highway projects. This account was capitalized primarily through a transfer of State Highway Fund monies. These funds carry Oregon constitutional and statutory restrictions.

- **645-05 -- SIB Highway Repayment Account:**

Balance: \$10,415,811

Description: This account is capitalized by non-federal sourced repayments for loans made from this account and the 645-01 SIB account. The purpose of this account is to originate loans for Title 23 and Title 49 purposes. Repayments from the original recapitalization that are from non-federal sources are not subject to full federalization requirements when loaned back out.

FFY 2025 Loans

From its inception to September 30, 2025, OTIB originated a total of 64 loans. OTIB has 32 active loans with an outstanding principal balance of \$19,980,732, and an additional \$34,679,894 is obligated to borrowers but has yet to be drawn upon. The remaining 32 loans totaling \$57,818,544 are fully repaid. The average loan amount is \$2,024,000.


OTIB originated three loans in Federal Fiscal Year 2025:


