

## SECTION 00905 - REMOVAL AND REINSTALLATION OF EXISTING SIGNS

Comply with Section 00905 of the Standard Specifications modified as follows:

**00905.00 Scope** - In the paragraph that begins "This Work consists of..." replace the word "both" with the word "more".

Add the following bullet to the end of the bullet list:

- Modifying signs, modifying sign legends, and repairing existing signs as shown.

*(Use the following **subsection .10 "Modify and Repair Language"** when modifying or repairing extruded aluminum panel signs and sign legends.*

Add the following subsection:

**00905.10 Materials** - Furnish materials for modifying signs and legends, and for repairing signs, meeting the requirements of Section 02910.

**00905.40 General** - Replace the paragraph that begins "Do not remove signs ..." with the following paragraph:

Do not remove signs from existing supports until new supports are in place, ready to receive the signs. Install the signs on the new supports immediately after removing from existing supports. Furnish temporary supports as required. Furnish permanent supports according to Sections 00910, 00920, and 00930 as required.

Replace the paragraph that begins "Protect specific service signs ..." with the following paragraph:

Protect specific service signs (business logos) and TODS from damage, whether the signs are to remain in place or are placed on temporary supports, until reinstalled on permanent supports. Repair or replace damaged signs at no additional cost to the Agency. Liquidated damages are assessed against the Contractor in the amount of \$200 per Day for each sign out of service for more than 5 Calendar Days.

**(Use the following subsection .41 "Modify and Repair Language" when modifying or repairing extruded aluminum panel signs and sign legends.**

Add the following subsection:

**00905.41 Modify Legends** - Remove existing removable legends and install new legends as shown and according to 00940.45. Fill all rivet holes not covered by new legends with new blind rivets. Do not damage background sheeting and substrates.

**(Use the following subsection .42 "Modify and Repair Language" when modifying or repairing extruded aluminum panel signs and sign legends.**

Add the following subsection:

**00905.42 Modify Signs** - Modify signs as shown and according to Section 00940.

**00905.90 Payment** - Replace the paragraph that begins "Payment will be ..." with the following paragraph:

Payment will be payment in full for furnishing and placing all Materials, and for providing all Equipment, labor, and Incidentals necessary to complete the Work as specified.

**(Use the following subsection .90 "Modify and Repair Language" when modifying or repairing extruded aluminum panel signs and sign legends.**

Add the following Pay Item to the end of the Pay Item list:

(c) Modify Existing Signs and Legends ..... Lump Sum
