

## **ODOT's Emerging Small Business Program**

Since 1989, ODOT's Emerging Small Business (ESB) Program has helped Oregon's small business community overcome barriers to participation in the state's multi-billion dollar public contracting process. The ESB Program is a race- and gender- neutral program open to certified ESB certified firms. The work by these small businesses benefits Oregon through delivery of maintenance, safety, preservation, and public improvement projects to Oregon's transportation system.

### **ESB Program**

\$10m in funding across ODOT's Regions for construction projects. All ESB solicitations are posted on the OregonBuys e-Procurement System. Program goals for ESBs include:

- Experience work in a prime contracting role with a public agency.
- Increase capacity to perform and bid on public contracts; expand market share
- Build confidence in pursuing public contracts
- Grow firms sustainably
- Support public contracting as a piece of a successful business model of growth and expansion

#### What is an ESB Certified Firm?

- Has principal place of business located in Oregon
- Is an independent business and not a subsidiary of a larger firm
- Is properly licensed and legally registered in the State of Oregon
- Qualifies for one of the following two tiers:

**Tier 1**: Average 3-year gross receipts not exceeding \$2,499,109.91 for construction firms; not exceeding \$999,643.61 for non-construction firms; 19 or fewer employees

**Tier 2:** Average 3-year gross receipts not exceeding \$4,998.220.95 for construction firms; not exceeding \$1,666,073.09 for non-construction firms; 29 or fewer employees.

- Compete in an environment limited to businesses of similar size
- ODOT ESB projects are set aside for exclusive bidding by certified ESBs
- Sponsorships to trade / industry events
- Mentor-Protégé Program
- Project, technical and procurement assistance

# ODOT's Emerging Small Business Program

ODOT's Emerging Small Business (ESB) Program has millions of dollars in public contracts available each biennium, awarded throughout the five ODOT regions and available to be bid and awarded exclusively to certified ESBs. The contracts are limited to \$250,000 or less and are all accessed through OregonBuys, the State of Oregon's web-based eProcurement system.
