Freight/transportation prices:

FREIGHT RATE: Freight rate is based on mileage from White City or Nampa ID terminal to the jobsite. The attached Freight Rates sheet lists representative cities. For in between points, contact the contact person listed on the sheet. Minimum load sizes apply.

FUEL SURCHARGE: A fuel surcharge will apply for each delivery based on the last price published before the delivery in the U.S. Energy Information Administration Weekly Retail Gasoline and Diesel Prices index for diesel in the Rocky Mountain (PADD 4) area:

The fuel surcharge is determined as follows:

BFP = Base fuel price, established at \$3.10 / gallon

CFP = Current fuel price for the week of the delivery using EIA index referenced above

FPA = Fuel Price Adjustment (CFP - BFP)

If FPA is zero or less, there is no adjustment

If FPA is greater than zero, $(FPA/.05) * .86\%$ = fuel surcharge percentage (.0086 as decimal)

Fuel surcharge percentage * freight rate from Freight Rates sheet = fuel surcharge

Fuel surcharge + freight rate from Freight Rates sheet = final per ton freight rate

EXAMPLE:

28 tons delivered to Roseburg January 5, 2024

Freight rate from the Freight Rates sheet: \$40 per ton

Base fuel price (BFP): \$3.10

Current fuel price from index dated 1/1/2024 (CFP): \$3.887

FPA (Fuel Price Adjustment): $\$3.887 - \$3.10 = \$.787$

Fuel surcharge percentage calculation: $.787/.05 = 15.74$ then $15.74 * .0086 = .1345$ or 13.45%

Multiply fuel surcharge percentage by freight rate to get fuel surcharge: $.1345 * \$40 = \5.38

Add fuel surcharge to freight rate to get final per ton freight rate: $\$5.38 + \$40 = \$45.38$ per ton

Please note: The attached Fuel Surcharge Schedule shows historical Dept of Energy index numbers on the left, and fuel surcharge percentages for each 5 cent increase to the base fuel price on the right. Instead of undertaking the calculation above you could get close by looking at the table on the right to see that at a price of \$3.90 (.80 FPA) the fuel surcharge percentage is 13.76. That would result in a final freight price of \$45.50.

Miscellaneous prices:

Pump Charges when pumping into storage \$150.00 per use.

Demurrage: 2 hours free unload, then \$150 per hour thereafter. Clock starts 2 hours after “agreed upon due time specified by customer **or start of unload if before scheduled due time**”. For example, if the transport is due 8am, at 10am, the demurrage clock starts if he has not been “unloaded and released”. The clock stops when the transport truck is “unloaded and released/free to leave the jobsite”, not when the vehicle actually departs. The “due time”, “start unload” & “finish unload” is documented on the bill of lading and the customer signs to acknowledge these times (and if any demurrage exists).

Truck hold fee for each truck placed on hold by the customer in excess of 2.00 hours, \$150.00 per hour (en route or still in plant ready to leave).

Per Diem for Spreader Operators required to remain onsite or when unable to work due to weather or breakdowns: \$450.00 per night. This covers their travel to and from a local/regional hotel/motel, their overnight stay, plus food etc. This charge will apply to any distributor which, due to hours of service, daily workload, weather, customer breakdown or excess oil in their tanks, is required to remain on the jobsite (or nearby hotel/motel accommodation). Charge is per distributor, per night.

Return Freight on oil hauled back to plant (breakdown/weather/cancellation) ½ rate on the quantity returned (eg \$45.00 rate from Nampa to jobsite x 50% rate for returns x 8 tons returned due to rain = \$180.00 charged for the return). Full freight charges to destination and ½ freight charges will be assessed on returned product.

No credit will be given for diluted materials.

Overnight holdover for transports held overnight at jobsite: \$450.00 per unit, per night.

Restocking fee for returned product: \$250.00.
