 - ii. Coatings Supplemental Warranty Performance Bond (signed by the Surety's authorized Attorney-in-Fact with the Surety's seal affixed to the bond)
 - iii. Power of Attorney for the Attorney-in-Fact (include the bond numbers, and affix the Surety's original seal to the power of attorney; if executed by co-Sureties, each Surety shall sign, seal and attach the power of attorney)

4. **Smoothness Data:**
 - a. Email raw data to the Assistant Pavement Materials Engineer at ODOTMixDesign@odot.Oregon.gov if requested or notified by Pavements that the project has been selected for QA.
5. **StatSpec Data:**
 - a. Email raw data of final statistical testing input data and statistical computation sheets to Pavements Unit at ODOTMixDesign@odot.Oregon.gov - all projects.

6. **ADA Curb Ramp and Push Button Inspection Forms:**
 - a. Ensure all ADA Curb Ramp and Push Button Inspection forms (on or along State highway system) have been sent to the ADA Unit directly from the dynamic (live, fillable) form using the red “Submit by email” button in the top right-hand corner.
 - b. It is critical all ramp forms are accounted for in the reporting required by the ADA settlement agreement.
