

## Driver License Standing Displayed on DMV2U

**Cancelled:** Your driving privilege or eligibility to apply for this privilege has been cancelled. If you currently have an Oregon driver license or permit, your license or permit is no longer valid. Stop driving and return your license or permit to DMV. Failure to return a suspended, revoked, or canceled license or permit to DMV is a Class C misdemeanor. (ORS 809.500). Driving with a cancelled license or permit can result in law enforcement issuing you a citation for driving without a license.

**Eligible:** You may be eligible for driving privilege. Visit this page for application requirements: <https://www.oregon.gov/odot/DMV/pages/driverid/licenseget.aspx>.

**Eligible to Reinstate:** You may be able to reinstate your driving privilege. There may be other requirements which include paying a reinstatement fee. A reinstatement fee can be paid online at <https://dmv2u.oregon.gov/eServices/?link=reinstate> or at a DMV field office (Customer Assistance cannot accept payments over the phone). If you have paid your reinstatement fee, please call Customer Assistance at (503) 945-5000 for more details. Statewide Relay (TTY): 7-1-1.

**Expired:** Your driving privilege has expired. You may be eligible to renew your license online at <https://dmv2u.oregon.gov/eServices/?link=renew> or at a DMV field office. Driving with an expired license can result in law enforcement issuing you a citation for driving without a license.

**Non-Valid:** Your driving privilege is not valid. Please call Customer Assistance at (503) 945-5000 for more details. Statewide Relay (TTY): 7-1-1. Driving without a valid license can result in law enforcement issuing you a citation for driving without a license.

**Revoked:** Your driving privilege or eligibility to apply for this privilege has been revoked. If you currently have an Oregon driver license or permit, your license or permit is no longer valid. Stop driving and return your license or permit to DMV. Failure to return a suspended, revoked, or canceled license or permit to DMV is a Class C misdemeanor. (ORS 809.500). Driving during a period of suspension or revocation can result in law enforcement issuing you a citation for driving while suspended or revoked.

**Suspended:** Your driving privilege or eligibility to apply for this privilege has been suspended. If you currently have an Oregon driver license or permit, your license or permit is no longer valid. Stop driving and return your license or permit to DMV. Failure to return a suspended, revoked, or canceled license or permit to DMV is a Class C misdemeanor. (ORS 809.500). Driving during a period of suspension or revocation can result in law enforcement issuing you a citation for driving while suspended or revoked.

**Valid:** Your driving privilege is valid. You must carry your license or permit while operating a motor vehicle. Lost, damaged, or stolen cards may be replaced online at <https://dmv2u.oregon.gov/eServices/?link=replace>.

**Valid with Hardship Permit:** A Hardship Permit is currently in effect. You must carry your Hardship Permit letter in addition to a valid drivers license at all times while driving. Your driving purpose and restrictions must be in accordance to the issued Hardship Permit letter.

**Valid with IID:** Your driving privilege is valid with an ignition interlock device used in any vehicle you operate or with a proper exemption waiver.
