- A. Demographic Information: Contains Name, Residence/Mailing Address, License number and other information about the subject of the record.
- B. License Information and Status: Displays the class of License the person has if any, along with any applicable Endorsements/Restrictions.
 - a. Status: Displays the status of any license or ID card the person may have along with the date and time that the status was effective.
 - b. Possible statuses include
 - i. Eligible
 - ii. Valid
 - iii. Expired
 - iv. Suspended
 - v. Revoked
- C. Record Type
 - a. Record Types Available
 - i. Certified Court Print
 - ii. Certified Court Print with Medical Certification
 - iii. Non-Employment Driving Record
 - iv. Employment Driving Record
 - v. Open-Ended Non-Employment Driving Record
 - vi. Driver License Information
- D. Address Updates
 - a. List of dates when the address was updated
- E. Issuance History
 - a. List of dates when an issuance was completed and the specifics about that issuance.
- F. Convictions
 - a. Lists date of violation and Oregon Revised Statute (DUII – 813010), Verdict (conviction) date, along with other information about the Conviction
- G. Withdrawals (Suspensions)
 - a. Lists the type of restraint (suspension, revocation, cancellation), Starting/Ending dates, reinstatement date if it has been reinstated along with other information about the restraint.
- H. TSA security check
 - a. List of dates when DMV has received notice from TSA in regards to Hazmat security checks
- I. Ignition Interlock Requirements
 - a. Lists start/ending dates if an IID is required
