Transit Bench or Shelter Outdoor Advertising Sign Checklist for Permit Application

Use this checklist for assistance in completing the application before sending it to ODOT. See administrative rule on permit applications and processing for complete details. We cannot process incomplete applications

Part 1 – Applicant Information, Sign Specifications

Fill in all information.

- ☐ The applicant must be an individual or a legal entity such as a corporation or partnership. Fill in name exactly as it legally exists.
- ☐ Fill in name and address of property owner at proposed sign location. If it is on city right-of-way, so indicate.
- ☐ Check the appropriate box – whether this sign will be on a bus/transit bench or on a bus/transit shelter. Slightly different rules exist depending on which structure you are using.
- ☐ Fill in who will erect the sign. If not the applicant, that person must have a license from our office.
- ☐ Check the appropriate box: bench sign or shelter sign
- ☐ Check the box confirming you are including an official document, such as the route map, showing this is a stop on the route.
- ☐ Check the appropriate box: new sign or reconstructed sign. Do not check “new plate” as this is something only done by the ODOT office.
- ☐ Include all sign description information. If you have a photo you may include that instead of a sketch.
- ☐ Include all site information including Township-Range-Section (and sub-section) and tax lot, and estimate the milepoint. Indicate how you have marked the spot so ODOT staff can find it. Indicate if the bench or shelter is already on site.
- ☐ Mark whether the sign will be posted for compensation, or will not be at the location of some business or some activity open to the public. This makes it an “outdoor advertising sign” under the law.

Part 2– Review Certification of Applicant – DO NOT SIGN IT YET

- ☐ Do not yet sign the application. Verify that all information you have supplied is complete and accurate. Read the certification you will need to sign when complete.

Part 2 – Sign Certification of Applicant

- ☐ Once you have reviewed the application for completeness and accuracy print your name and title if you are signing as a representative or a corporation or other legal entity. Sign and date the certification.

Other Required Items / Submitting the Application

- ☐ If the sign is being erected on property owned by someone else, include a copy of the lease or a written statement from the property owner stating you have permission to erect the sign there. The document must be signed by the landowner and dated.
- ☐ Include a current route map of the bus/transit system, or other official document, showing this is a stop on that route. Bench signs may only be located at a bus or transit stop on a city or urban transit system route.
- ☐ Determine the correct fee (see front of this form) and include a check for that amount, made out to Oregon Department of Transportation.
- ☐ Mail or deliver the original application form, and other required items to:
