# Instructions

**Use this form when you are applying to title an assembled trailer that has never been titled or registered before AND was not made by a manufacturer.**

Complete the form and sign it. If you do not provide the ownership or trailer information needed, we may ask you for more information or documents, or we will return your transaction.

**You must submit:**

- Receipts or bill(s) of sale for both the frame and axle if you built the trailer.
- A release of interest from the party you bought the trailer from, including any receipts, if you didn't build it.

If you cannot provide either of these items, you must explain on the front of this form.

A vehicle identification number (VIN) inspection at a DMV field office is required. There is a \$9 fee for the inspection. You must submit other fees (title, and any registration) and a title application. If the trailer does not have a VIN, DMV will assign one.

Completing this form does not guarantee issuance of a title.
