The evidence of interest that you submit **must**:

- a. include a description of the vehicle (at least the Oregon plate number or vehicle identification number).
- b. include your name, and
- c. show that you have an interest in the vehicle.

List of acceptable documents (the list below is not exhaustive):

- Bill of sale
- Contract/purchase agreement
- Odometer disclosure
- Copy of Oregon title/salvage title
- Security Agreement
- Small estate certification
- Lease agreement

- Final divorce decree
- Inheritance affidavit
- Court order specifically awarding vehicle
- Proof of insurance
- Repair bills
- Form 735-550

Or any other documentation that supports your claim to financial interest in the vehicle. If you submit a non-standard document, please include your reasoning for including the document in the explanatory portion of the form.
