Verify complete content:

- Driver information;
- The description of unsafe or dangerous driving behavior, including observations;
- Additional descriptive information, if any, including any relevant historical information; and
- Your information, including a signature and date. DMV is prohibited from accepting an anonymous report.

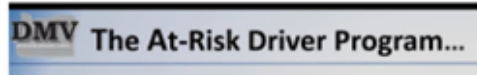


After a report is submitted...

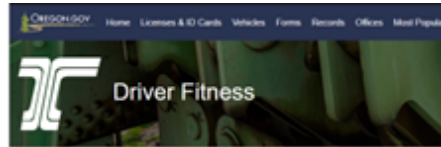
- It's screened against criteria in statute and rule.
- The reporter is notified by mail of acceptance or rejection.
- When accepted, the driver will receive a suspension notice with the terms of the suspension, including steps to take to regain driving privileges.

Balancing Independence with Public Safety...

By preserving the independence, dignity and self-esteem derived from transportation independence...
So long as it is possible to do so without risk to oneself or to others.

Who is an At-Risk Driver...

Any driver – aged 14 or older – who is unable to drive safely due to a health condition or impairment.

As a function-based program, having a diagnosis of a condition or impairment, or taking medications that may affect driving, does **not** automatically make that person an At-Risk Driver.



What can be done...

The driver can:

- Work with their medical provider to assess the impact of the condition(s) on driving.
- Obtain Driver Rehabilitation services to assess and improve driving (see Oregon **Driver Fitness** webpage, address on back).
- Request DMV testing to assess the ability to drive safely.

The family may find the related resources on the Oregon **Driver Fitness** webpage helpful (web address on back).

And... reporting a driver can help them get the assessment and assistance they may need.

When to report...

When driving behavior gives reason to believe they may no longer be able to drive safely... even when/if you:

- Think or believe someone else will or should report; or
- Have reported before and the report was rejected.

DMV has the authority to combine multiple reports when, individually, they may be insufficient. Acceptance, however, is not guaranteed.

What to report...

Unsafe or dangerous driving behavior (OAR 735-076-0002(11)) is when:

"...A driver is unable to perform basic driving tasks in a safe and responsible manner..." For instance:

- **The driver is prevented from causing a crash by** an evasive maneuver by another driver(s);
- **The driver impedes traffic or fails to yield the right of way**, such as: driving too slowly; driving in more than one lane of traffic; turning from the wrong lane; or turning into the wrong lane; and
- **Failure to obey or difficulty obeying a traffic control device**, such as: running a red light or stop sign; stopping beyond the designated stop line at a traffic light or stop sign; failing to stop for a pedestrian in a marked crosswalk; or driving the wrong way on a one-way street.

How to report...

Complete a **Driver Evaluation Request** (see **Reporting an Unsafe/At-Risk Driver** webpage, address on back) and submit it to DMV.

For DMV to take action, law requires the Request to include:

- **Driver information** "sufficient for DMV to identify the reported person" (not the vehicle);
- **A Description** that will "give DMV reason to believe the person may no longer be qualified ... or able to drive safely," such as:
 - Specific observations and why** they make you think the driver may no longer be able to drive safely.
- **Reporter information** including your name and signature. **DMV is prohibited from accepting anonymous reports.**



Confidentiality...

By Oregon law (ORS 807.710(6)), all reports – *not submitted by Law Enforcement or the Courts* – are confidential. **The report and any information contained in it cannot be released to anyone** outside of a court order or Administrative Hearing proceeding.
