Valid With Previous Photo (VWPP) / Valid Without Photo (VWOP) Good Cause / Waiver Certification

DMV received your request for a valid with previous photo (VWPP) license, permit or ID card. You **MUST** complete this form and return it with your application. If this form is not completed and returned, DMV cannot process your application.

I certify that (check only one of the following):

I am temporarily outside of Oregon for business, employment, or educational reasons. Even though I am away from Oregon, I am continuing to satisfy Oregon's residency requirements and plan to return to Oregon.

I am traveling outside of Oregon and my driver license or ID card has been lost, stolen or mutilated.

I am traveling outside of Oregon and discovered that my driver license or ID card has expired or will expire prior to my return.

I have a health problem or medical condition that prevents me from being able to renew or replace my Oregon driver license or ID card at a DMV field office. *Attached is a letter signed by my licensed medical provider who is treating me for this condition.

I am an active duty military service member of the U.S. Armed Forces stationed outside of Oregon needing to renew or replace my Oregon license or ID card.

I am a spouse, domestic partner, or dependent of an active duty military service member stationed outside of Oregon needing to renew or replace my Oregon license or ID card.

I am temporarily outside of Oregon wanting to add a motorcycle endorsement to my current driving privilege.

I understand that my last photograph taken by DMV must be **less than nine years old** to qualify for issuance of a VWPP driver license or ID card.

I am an active duty member of the U.S. Armed Forces stationed outside of Oregon, or a spouse, domestic partner, or dependent of an active duty military service member stationed outside of Oregon who does not have a photo on file with DMV that qualifies for issuance of a VWPP renewal or replacement license or permit; therefore, I am requesting a VWOP license or permit.

NOTE: You must provide proof of being a citizen or lawful permanent resident of the United States to DMV. Acceptable proof includes a copy of your U.S. government-issued birth certificate, U.S. Passport or Passport card (expired less than 5 years), Request for Verification of Birth (DD372), U.S. Consular Report of Birth Abroad (FS-240), Certification of Report of Birth (DS-1350 or FS-545), Tribal ID card from a federally recognized tribe located in Oregon, Certificate of Citizenship (N560 and N561), Certificate of Naturalization (N550, N570 and N578), or Permanent Resident card (I-551).

By signing and dating this form, I acknowledge that when I next renew or replace my driver license, permit or ID card at a DMV office I may be required to provide the original or certified copy of the documents used to prove I am a citizen or lawful permanent resident of the United States with the VWPP or VWOP application.
