

The fees you will pay are:

- Regular Class C Knowledge test: \$5.00
- Safe Driving Practices knowledge test: No Fee
- DMV driving (behind-the-wheel) test: \$9.00
 - Third party (private party) testing fees may vary.
- Application for an instruction permit: \$23.00
- Application for a driver license: \$60.00
- Application for an ID card: \$44.50

You will need an appointment to:

- Take a regular Class C knowledge test (you can do this at the same time as you apply for your license or instruction permit)
- Take a Safe Driving Practices test
- Take a drive (behind-the-wheel) test
 - You can also take a drive test with a DMV contracted testing business. Wait times for an appointment may be shorter.
- Apply for a license or ID card. (You can do this at the same time as your knowledge test)

Driver Licenses for All

What does House Bill 2015 do?

House Bill 2015 removes the requirement to prove legal presence when applying for a standard Oregon driver license or ID card. A standard driver license or ID card is not Real ID compliant. All other requirements such as proof of name, identity, date of birth and Oregon residency stay the same.

A REAL ID version of a driver license or ID card is different – you need to show proof of lawful status to qualify.

When the TSA starts enforcing REAL ID on October 1, 2021, you will NOT be able to use a standard driver license to get on a plane. You will need a valid passport, a REAL ID, or other federally acceptable document to board a plane. Requirements for Real IDs and commercial driver licenses are not changing. You need five primary things to get a standard driver license or ID card:

- Complete an electronic application at a DMV office
- Present documents showing your identity, date of birth, legal name and residence address
- Provide your SSN, if you have one (if you do not have one, that's ok)
- Pass tests, if applicable (driver license only)
- Pay fees

Under HB 2015 will DMV be issuing driver licenses or ID cards to undocumented immigrants?

House Bill 2015 removes the requirement for all individuals to provide proof of legal presence when applying for a driver license or ID card.

Will I need to provide my Social Security number to get a standard driver license or ID card?

Yes, if you have a Social Security number you will need to provide it. If you haven't been assigned an SSN, you can still get a standard license. You will sign an electronic statement certifying that you haven't been assigned an SSN when you are at DMV.

You do NOT need to prove legal presence for a standard driver license or ID card. You do need to prove:

- Identity – you are who you say you are
- Your current legal name
- Date of birth
- Residence address – where you live

When will HB 2015 go into effect?

The new requirements from HB 2015 go into effect January 1, 2021. Until that date proof of legal presence is still required for a driver license or ID card.

Is this a new type of driver license or ID Card?

No, House Bill 2015 only changes the requirements to apply for a standard driver license or ID card. The driver license and ID card will be the same as the current license

and ID card, with all the same features. A standard driver license or ID card is not Real ID compliant.

Does HB 2015 only apply to non-US citizens?

No, beginning January 1, 2021 all individuals applying for a standard driver license or ID will no longer need to provide proof of legal presence.

For a driver license you need to take and pass these tests:

- Age 18 and older:
 - Valid or expired less than one year driver license from another state: knowledge test & vision screening
 - No driver license, or Oregon driver license expired over a year: knowledge test, vision screening, and drive test
- Under age 18:
 - Valid driver license from another state: knowledge test, Safe Driving Practices test, and vision screening.
 - No driver license: knowledge test, vision screening, Safe Driving Practices test, and drive test.

* Drivers under 18 need to have held an instruction permit for at least 6 months prior to taking a drive test.

* Instruction permit holders under 18 need to have either (a) taken an approved Teen Driver training course and practiced for 50 hours; or (b) practice for 100 hours prior to being issued a driver license.
