CERTIFY VEHICLE USE*:

TOW ONLY (TW) - THIS VEHICLE WILL BE USED TO TOW/HAUL WRECKED OR DISABLED VEHICLES ONLY

TOW PLUS (TP) - THIS VEHICLE WILL BE USED TO TOW/HAUL WRECKED OR DISABLED VEHICLE PLUS WILL BE USED TO TRANSPORT OTHER COMMODITIES. If other use includes for-hire, Oregon intrastate operations, 1A Permit Authority is required.

Registration fees are based on use of the vehicle for the calendar year. Changing from TOW ONLY to TOW PLUS during the registration year will result in an increase of registration fees. There is no credit or refund of fees to change from TOW PLUS to TOW ONLY during the registration year.

Tow or Recovery Vehicle must be registered at the "fully equipped for service" weight; plus:

- Tow or recovery vehicles that transport vehicles on the bed of the recovery vehicle must include the loaded weight of the tow/recovery vehicle in the registration weight;
- Tow or recovery vehicles that transport vehicles using a trailer must include the empty weight of the combination in the registration weight.

COMBO #1	DECLARED WEIGHT	AXL	Solo weight plus weight of heaviest towed power unit such as truck-tractor, motor home, bus or motor truck.
COMBO #2	DECLARED WEIGHT	AXL	Solo weight plus: 1) weight of heaviest single loaded vehicle such as a motor truck or trailer - up to 80,000 lbs.; or 2) weight of heaviest combination of vehicles such as a truck-tractor/semitrailer or truck and trailer combination - up to 80,000 lbs.
COMBO #3	DECLARED WEIGHT	AXL	Solo weight plus heaviest single vehicle or combination of vehicles when the total weight exceeds 80,000 lbs but is not more than 98,000 lbs.

This form is to be completed and filed when applying for: 1) Oregon Commercial Registration for tow vehicles; 2) Amend Registration for tow vehicles 3) Renew Registration for tow vehicles. NOTE: Registration is for Oregon Based Intrastate carriers and does not grant registration for travel outside the state of Oregon.

Enter your ACCOUNT NUMBER, BUSINESS NAME, EFFECTIVE DATE and TELEPHONE NUMBER and complete ADDRESS.

If you do not have a file number, this form must be accompanied by an APPLICATION FOR MOTOR CARRIER PERMIT, ODOT FORM 735-9075.

CLASS AND REGISTRATION WEIGHT (REFER TO OAR 734-076-0015 FOR COMPLETE TOW TRUCK DEFINITIONS)

CLASS A - minimum manufactured gross vehicle weight rating (GVWR) of 10,000 lbs. Gross weight of 26,000 lbs or less including weight of tow vehicle. Not authorized to tow a combination of vehicles. Register with DMV or apply for Apportioned Registration - use form 735-9684t.

CLASS B - minimum manufactured GVWR of 17,000 lbs. Tow/recover a single vehicle or combination of vehicles such as medium size vehicles. Shall have a combined gross vehicle weight of 80,000 lbs or less, not including the weight of the tow vehicle

CLASS C - GVWR of 27,500 lbs or equivalent. Tow/recover a single vehicle or combination of vehicles such as large vehicles. May have a combined gross vehicle weight up to 98,000 lbs inclusive of the tow vehicle except when operating under a single trip permit issued to the tow vehicle. Tow vehicles must have tandem drive axles.

CLASS D - transport disabled units upon the tow vehicle (AKA roll backs or tilt decks). May also tow a single vehicle of legal size using a crane, hoist, tow bar, tow line or dolly. All weights shall comply with ORS 818.010. Further identified into three sub-classes describing the design and use allowed if they also tow other vehicles appropriate to their class. Refer to OAR 734-076-0015. Not authorized to tow a combination of vehicles.

SELF PROPELLED CRANE - Used to facilitate the recovery of wrecked or disabled vehicles. Does not tow a load.

TRUCK-TRACTOR - Used in combination with a trailer and used to recover wrecked or disabled vehicles on the trailer

If your combined weight is in excess of 80,000 lbs., you must obtain an Oregon Over Dimensional Permit on [Oregon Trucking Online](http://OregonTruckingOnline.com) or by calling 503-373-0000 7am to 5pm Monday through Friday.
