



INTERSTATE REGISTRATION FEES

TOW AND MOBILE HOME TOTERS - Effective January 1, 2018

This fee schedule must be used for motor vehicles that qualify for and are registered as tow/recovery or manufactured structure toters; i.e. used only to tow or haul wrecked or disabled vehicles or to transport manufactured structures. Vehicles that are used to tow, plus haul other commodities must use the Fee Schedule for Heavy Motor Vehicles (Form 735-9969).
