This report summarizes the twelfth calendar year (2024) of the Oregon Department of Transportation's (ODOT) Federal-Aid Highway Program (FAHP) activities under the Federal Highway Administration (FHWA) statewide programmatic Endangered Species Act of 1973 (as amended) (ESA) section 7 and Magnuson-Stevens Act (MSA) consultation with the National Marine Fisheries Service (NMFS). The focus of this report is to meet FHWA's program reporting requirements as described in the NMFS Biological Opinion (BO) (WCRO-2021-0004). This report summarizes program use and incidental take for the calendar year, describes opportunities for improved conservation under the BO, and identifies program efficiency and accountability improvements. This report also provides information on program changes and reinitiation needs and performance (including construction) in 2025. FHWA and ODOT provided this report to NMFS and discussed it during the _____ annual meeting.

1.0 FAHP Programmatic Overview

The FAHP programmatic is designed to improve the efficiency, consistency, and conservation benefit of ESA section 7 consultations for FAHP projects. It is administered by FHWA and includes local government and state sponsored projects that fall within the scope of the program. FHWA serves as the lead Federal action agency for the FAHP programmatic and projects that also require U.S. Army Corps of Engineers (USACE) permits can use the FAHP programmatic to meet the USACE ESA requirements. The program action area includes all geographic areas in Oregon where transportation projects affect ESA-listed species currently covered by the FAHP programmatic (Table 1). There is no expiration date; however, reinitiation of consultation will occur as required under the ESA.

The FAHP does not provide ESA coverage for adverse effects to Southern Resident killer whales and their designated CH.

Tools

When the FAHP programmatic was initially implemented in December 2012, ODOT and FHWA developed several tools to meet the reporting requirements and assist with information sharing and management. The tools are updated as necessary and include:

- Initiation, Notification, Construction Inspection and Completion forms.
- Webmap – The location and status of all projects implemented using the FAHP are available for stakeholders to track via [ODOT's FAHP Projects Map](#). Each project is symbolized by its current status and includes a link to the project files. These contain more detailed information ranging from plan sheets to notification forms to construction monitoring reports.
- Project Tracking – All projects that use the FAHP are documented and tracked in a centralized data management system managed by ODOT. Project impacts, enhancements, and take are all tracked, and quarterly status reports are available to stakeholders.
- User's Guide – The [FAHP user's guide](#) is a comprehensive review of the processes used to implement the FAHP. The [user's guide](#) provides design standards, and detailed instructions for how to coordinate, notify, and monitor projects.

Training

In March 2024, ODOT and FHWA provided training for consultants as part of the '[ODOT Qualification Program for ESA Compliance](#)'. This training is required for consultant biologists who work on ODOT project ESA consultations and FAHP programmatic documentation. Future trainings will be provided as necessary to ODOT staff, FHWA, and consultant biologists.

ODOT fish salvage crew leaders are required to attend Smith-Root for electrofishing and fish handling training every five years to learn the latest techniques for fish salvage operations and how to minimize handling mortalities. Fish identification training was offered to all regions with several opportunities to participate in online sessions. Sessions included information on fish salvage techniques with an emphasis on ESA-listed fish identification and handling. The trainings were well attended by region biologists, environmental coordinators and hydraulic engineers. This training will be updated and offered again prior to the start of the 2026 summer construction season when most of salvages tend to occur.

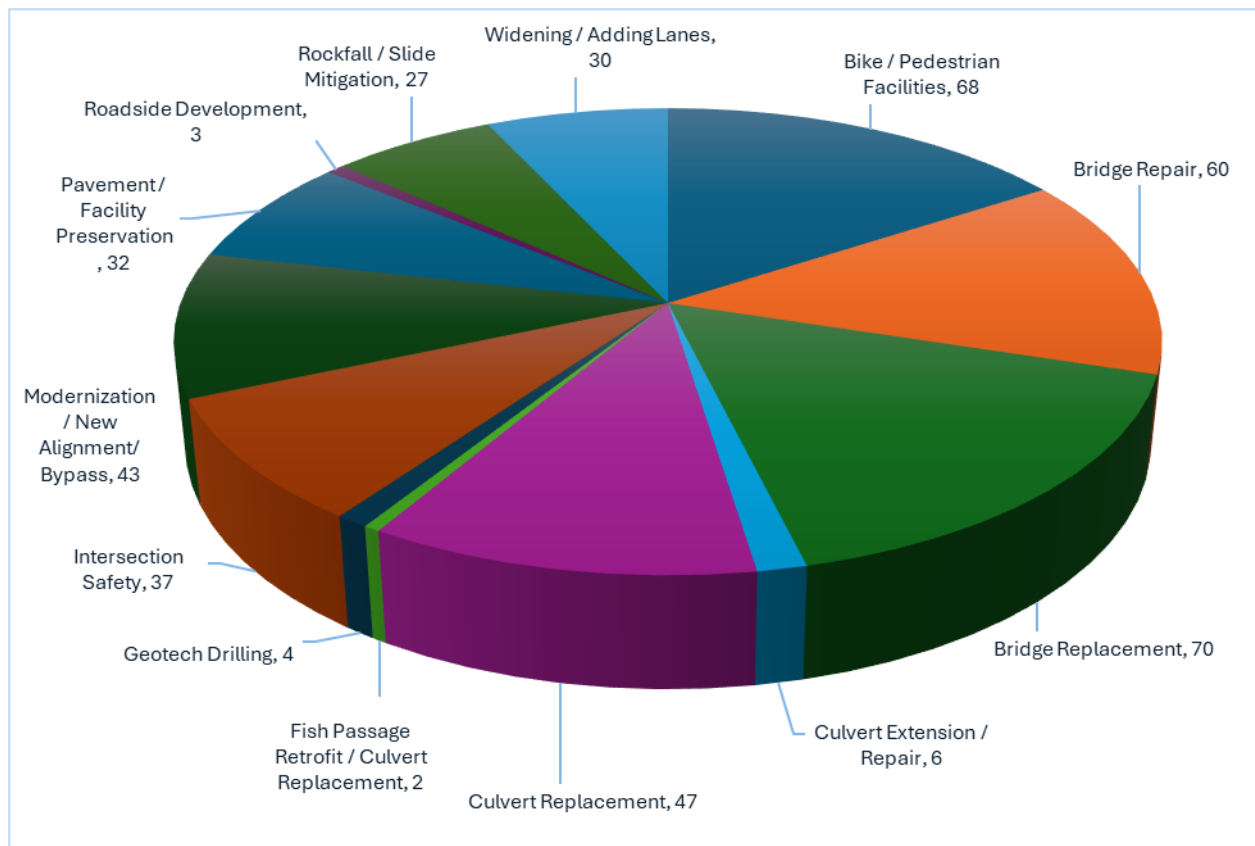
2.0 Anticipated Impacts and Permitted Extent of Take

The effects on NMFS ESA-listed species and critical habitat from transportation projects vary depending on their nature and scale. The FAHP programmatic includes the following project activities that may result in impacts to ESA-listed species:

- Barge use
- Bridge, culvert, and road maintenance
- Drilling and boring
- Habitat restoration
- Heavy-duty vehicles and equipment
- Painting and coating
- Pesticide-treated wood use
- Pile installation and removal
- Stream crossing replacements and improvements
- Surface water withdrawal
- Streambank or channel stabilization
- Temporary access road construction
- Tide gate replacements and retrofits
- Utility work
- Work area isolation

Figure 1 is a summary of project types that have used the FAHP programmatic since implementation in December 2012. The majority of projects are bridge replacements and repairs; although a wide variety of project types are represented by the 429 projects. In this graphic, we are tallying projects that have used the FAHP programmatic by totaling those projects that have initiated early coordination via the initiation form. Incidental Take associated with the projects is well below the amount exempted in the BO as described in Section 3.0. This low level of take can be attributed to the quality of the best management practices (BMPs) implemented by ODOT and the scope and scale of the actions. Significant efforts are made by project teams to avoid and minimize impacts to listed species and critical habitat.

3.0 Summary of Projects and Incidental Take in 2024

The BO exempted take by specific recovery domains. Each recovery domain has its own annual take limits that is actively monitored to track current take as well as projected take for projects that have not gone to construction. Take is also tracked as a cumulative total for the program since inception and often for several take categories, the program total is below the annual take exempted.

All projects covered under the FAHP programmatic require review by FHWA, however, only certain types of activities require review and verification by NMFS. Actions requiring NMFS verification include the following:

- Actions with required mitigation such as: on-site stormwater deficit, net increase in artificial fill or abandoned fill in the functional floodplain, unvegetated streambank riprap, streambank riprap above ordinary high water, and in-stream flow control structure.
- In-water work extension requests or significant project changes.

- Projects that require NMFS fish passage design review.
- Fisheries restoration structures or fishways, including ladders, culvert retrofits, pool-riffle structures, and roughened chutes.
- Dam or water control structure removal
- Replace, modify or remove tide gate
- Alternate sound attenuation for pile driving
- Construction Blasting.
- Bridge replacement that cannot meet fluvial performance or pile driving standards.
- Modification of any part of the proposed action that may affect listed species or critical habitat in a manner that is consistent with the effects analysis of the opinion and the take statement.

In 2024, only one project, the Willamette River: Source Control Improvements Project required an individual formal consultation with NMFS (outside of the FAHP programmatic). There were 19 projects which submitted Notifications for verification (NMFS and FHWA or just FHWA) in 2024 (Table 2). Some of the projects which submitted Notifications in 2024 began the FAHP process with Initiation form submittals in 2023 or earlier. date the project is officially submitted to FHWA. If a project is not submitted correctly or information is missing from the submittal, the review time doesn't start until the submittal is complete. Projects that withdraw submittals (either to make corrections or to capture project changes) and resubmit later also have their timelines restarted.

Project approval time for NMFS approval starts after FHWA has approved the project and notified NMFS through the email submittal process. Most of the projects that are sent to NMFS from FHWA have the required documentation. Generally, the quality and completeness of submittals has continuously improved resulting in more efficient review timelines. ODOT recently implemented a more robust quality control process with peer and liaison reviewed checklists. This process has been more consistently implemented and we have received feedback on how to improve our review processes.

There were 11 projects in 2024 that requested an in-water work extension and/or project change which resulted in a total of 13 submittals. The most common reason for extensions was unexpected delays during construction, especially with high water levels.

3.1 Interior Columbia Recovery Domain Take Summary

The Interior Columbia Recovery Domain had 58 projects at various stages in the FAHP process in 2024 (6 projects in early coordination, 7 projects ready for construction, 6 projects in construction and 39 projects that have completed construction). The anticipated take is summarized in Table 3. The anticipated running total accounts for the take anticipated to date under this programmatic for this recovery domain. This will be updated as appropriate following construction to reflect actual take (for instance, actual piles driven on a bridge replacement project may differ from what was estimated in the notification form). Annual take allocations are significantly below their annual take allocation in the Interior Columbia Recovery Domain.

3.2 Willamette / Lower Columbia Recovery Domain Take Summary

The Willamette / Lower Columbia Recovery Domain had 237 projects in the FAHP process in 2023 (11 projects in early coordination, 32 projects ready for construction, 27 projects in construction and 167 projects that have completed construction). The anticipated take for the Willamette / Lower Columbia Recovery Domain is summarized in Table 4. As of December 31, 2024, our projects are significantly below their annual take allocation in the Willamette / Lower Columbia Recover Domain and our projections are showing this trend continuing into future years.

3.3 Oregon Coast Coho Recovery Domain Take Summary

The Oregon Coast Coho Recovery Domain had 96 projects in the FAHP process in 2024 (8 projects in early coordination, 6 projects ready for construction, 7 projects in construction and 75 projects that have completed construction). The anticipated take for the Oregon Coast Coho Recovery Domain is summarized in Table 5. As of December 31, 2024, our projects are significantly below their annual take allocation in the Oregon Coast Coho Recovery Domain and our projections are showing this trend continuing into future years.

3.4 Southern Oregon / Northern California Coho Recovery Domain Take Summary

The Southern Oregon / Northern California Coho Recovery Domain had 38 projects in the FAHP process in 2024 (4 project in early coordination, 2 projects ready for construction, 6 projects in construction and 26 projects that have completed construction). The anticipated take for the Southern Oregon / Northern California Recovery Domain is summarized in Table 6. As of December 31, 2024, our projects are significantly below their annual take allocation in the Southern Oregon / Northern California Coho Recovery Domain and our projections are showing this trend continuing into future years.

3.5 Construction Monitoring

In 2024, there were 55 projects that were scheduled to be in construction with ESA coverage provided by the FAHP programmatic. While every one of these projects is required to submit at least one construction monitoring report per year, at the time the report was drafted, only 52 projects have submitted them as required to the FTP folders. The projects missing reports were small stormwater only projects without any in-water work. Local agency projects continue to be challenging to ensure compliance with the construction monitoring requirements. ODOT staff will continue to be encouraged to complete a report whenever a site visit is made to properly

document the visit, even if they already have met the minimum requirements for the construction year. Projects that identified issues needing correction were more likely to submit several monitoring reports. There was a total of 96 official construction monitoring reports representing 98 site visits submitted in 2024.

The construction monitoring requirements are helping to ensure compliance with the BO Terms and Conditions. These monitoring reports can be viewed by using the [FAHP ESA Programmatic Webmap](#). Overall, during construction, the projects are complying with the BO requirements. The most common issues identified included: erosion control fencing maintenance, weed control, and construction debris management. These items were easily corrected by the contractors. According to the documented inspections, overall compliance has improved over previous construction seasons. The extensive outreach across the state with all of the environmental coordinators, biologists, resident engineers and construction inspectors appears to be working. Additional training and outreach will occur in 2025 to emphasize the importance of construction compliance. Region staff will be reminded of the importance of construction inspection reporting during regularly scheduled check in meetings.

ODOT also delivers inspector trainings which emphasize the most commonly noted issues during inspections and appropriate preventative actions. We are continually modifying our training materials to add emphasis in areas identified as problematic based on our construction inspection reporting.

3.6 Conclusions

The verification timelines have significantly improved compared to the initial years of FAHP programmatic use. The NMFS verification timeline has increased slightly to 10 days when compared to 2023. The FAHP programmatic verification is much faster than individual formal consultations that would have been required for most projects due to stormwater-related and other potential effects. The goal for the program was for FHWA to review projects in 2 weeks and for NMFS to review projects in 30 days. In 2024, FAHP projects averaged 5 days for FHWA verification, and 10 days for NMFS verification. Achievement of approval time goals can be attributed to stakeholders familiarity with the program requirements, improved quality of the Notification and supporting documentation, effective coordination from liaison staff, and more expedited reviews by FHWA and NMFS.

ODOT is widely successfully designating and implementing BMPs and minimizing impacts to listed fish and associated habitat. ODOT and FHWA are significantly below the annual allocated take for the FAHP programmatic in all recovery domains for the 2024 construction year. In 2024, there were 34 fish salvage operations for 20 FAHP programmatic projects. Of these 20 projects, 8 encountered listed fish during salvage operations. One project in the Interior Columbia recovery domain salvaged a total of 275 juvenile steelhead over a total of five salvages with 11 known mortalities. Nine of these mortalities could have been avoided if the contractor

hadn't allowed flow into the temporary bypass pipe before it was fully installed. The additional training and practices put in place after the 2015 construction year have reduced mortalities during fish salvage operations. Increased emphasis on temporary water management and the sequencing of the implementation of this critical work will occur this year. In 2025, we expect a lower number of projects with fish salvage operations across the state.

4.0 Actions to Improve Program Conservation, Efficiency, and Accountability

The FAHP ESA Programmatic is closely monitored by ODOT and FHWA to ensure that it is performing efficiently and minimizing impacts to listed species and that the stakeholders are performing the duties required under the agreement. We intend to provide updated guidance materials for consultants, FHWA and ODOT biology staff by revising the User's Guide in 2025. ODOT and FHWA continue to conduct multiple meetings in every region with project managers, construction managers, construction inspectors and other staff to emphasize the importance of construction inspection and compliance.

As part of adaptive management, we've created a requirement for every project that has temporary water management to hold an additional on-site pre-construction meeting within 8 calendar days of commencing that work. This requirement is in our special provisions under the temporary water management section. We've already noticed a significant improvement and believe that these actions will continue to help reduce the risk of additional take. As this program continues, we will discover additional ways to increase efficiency in our reporting and documentation processes. New technology and construction techniques will add to our ability to minimize take of listed species.

4.1 Data Management

As of December 31, 2024, we've recorded 897 unique site inspection reports representing a wide range of project types across the state. The data management system allows improved tracking of reoccurring issues on construction monitoring reports and identification of any common characteristics between them such as the contractor, the inspector, proponent agency, geographical location, or other possible causations. ODOT and FHWA analyze and discuss the data from these construction monitoring reports to identify areas where our training needs improvement and implement these changes rapidly. We continue to modify our inspection forms as needed and are implementing process improvements. We anticipate better data now that inspection reports have been updated to allow expandable fields to list issues noted along with more detailed information on how they were corrected. New project notification forms are finishing up development to meet the needs of the new biological opinion. These forms feature expandable fields and reduce the number of separate PDF forms that need to be incorporated with each project notification.

4.2 Stormwater Treatment

Since inception, the FAHP Programmatic has emphasized the importance of avoiding, minimizing and mitigating effects on listed species and critical habitat from the many contaminants in roadway runoff. A cornerstone of the established standards in treating not only new impervious area created by covered projects but treating the Contributing Impervious Area (CIA). The CIA includes agency-controlled impervious areas that are within or contiguous to the project area and discharge runoff into the project area. This standard results in built-in retrofit of untreated areas for all projects that require stormwater treatment. For the 2024 reporting year:

17 projects triggered stormwater treatment;

16.524 acres of new impervious area created;

39.22 acres proposed to be treated;

The proposed treatment BMPs include:

- Bioretention cell/bioswale – 35%
- Bioslopes – 45%
- Natural infiltration via existing vegetation with suitable soil, slope and distance from connections to flowing water – 20%

4.3 Environmental Enhancements

The FAHP ESA Programmatic is monitored by ODOT and FHWA for positive environmental outcomes that result from project construction. In 2024, one culvert replacement project restored access to 0.39 miles of fish habitat. In 2024, the 34 projects that completed construction created 15.28 acres of new pollution-generating impervious area but built facilities to treat 77.95 acres of impervious surface area. This means that the FAHP programmatic facilitated capture and treatment of runoff from 62.67 acres of existing pollution-generating impervious area, which should contribute to improved water quality in receiving waters.

Figure 2. Overview of all projects using the FAHP for ESA coverage statewide.

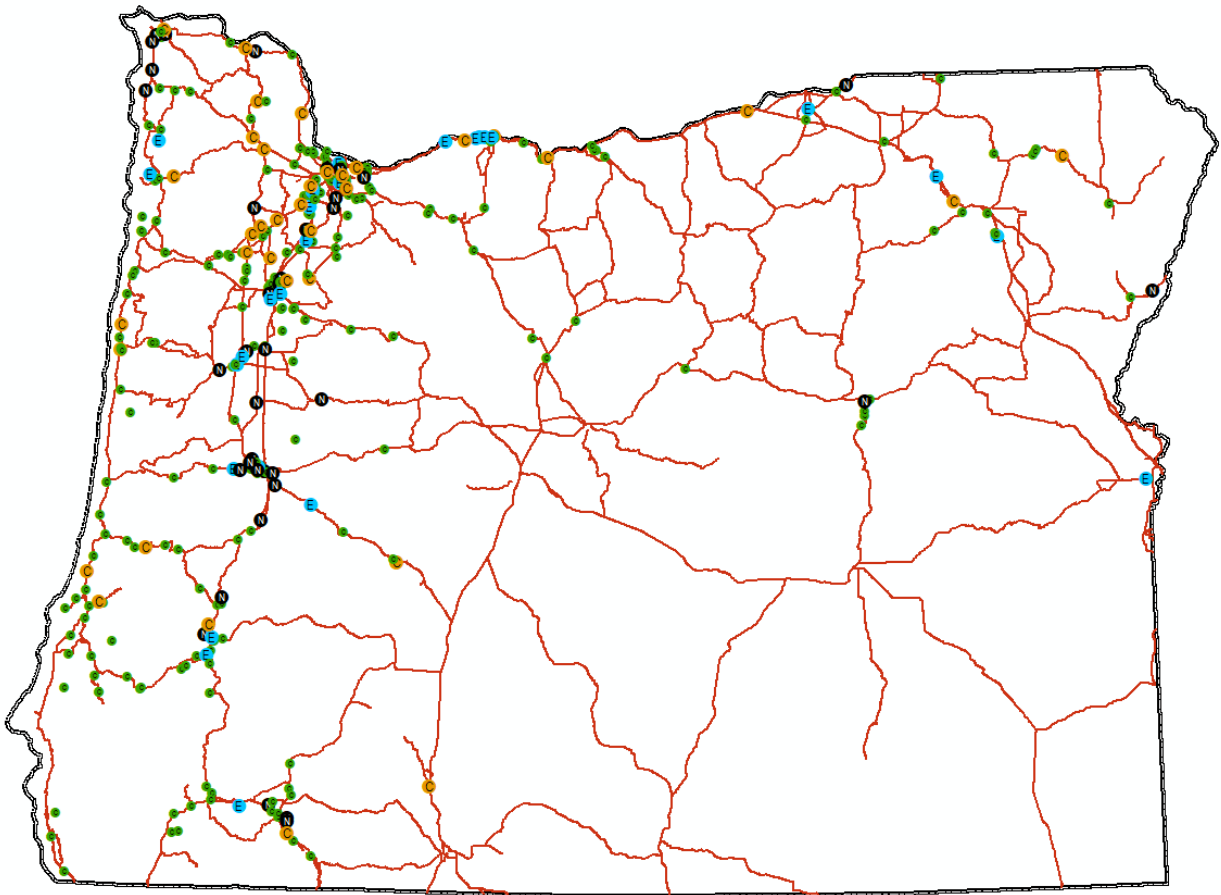
