OTC/Regional Updates - Ken Patterson

> OTC

- ✓ The OTC will meet in Pendleton at the Wildhorse Resort for their July meeting. An hour has been scheduled for comments from ACT and CTUIR members
- ✓ The Interstate Bridge project has been funded \$1B in general funds. This is the first time we have seen general funds used for this type of project
- ✓ Presentations on Strategic Plans will be coming out. OTC would like to adopt by later 2023

Regional Updates

✓ News is around the delay of the Rose Qtr and widening of Stafford Road. This is a result of the Tolling conversation. The Rose Qtr had extensive funding increases and without the Tolling revenue, the project is being put on hold

North East Area Commission on Transportation (NEACT)

24-27 STIP – Sean Maloney

- ➤ The draft is still open for comments and we expect approval from Federal Highway by October 1, 2023
- ➤ Allocation for the 27-30 STIP will be in January, Scoping starts in June 2024

Local Program Update: Michelle Owen

- SCA applications are open until July 31, 2023 and are online. Funding will be awarded in January
- ➤ The Notice of Funding Opportunities are available and Michelle will be sending those out as she receives them

- Karyn Criswell is no longer with ODOT. Stefanie Coons is acting as the Interim PTD Division Administrator

- PTD Planning is starting for the 27-30 STIP
- All but one agency in the NEACT has returned signed grant agreements for execution on July 1st. That agency will return their signed agreement mid-July

- Two agencies in the NEACT received their compliance review findings back this week. Angie will work with those agencies to answer questions and close findings
- ➤ Mandatory Drug and Alcohol training is occurring in Bend for Region 5 providers.

27 – 30 STIP – Ken Patterson, Region 5 Manager

North East Area Commission on Transportation (NEACT)

➤ The 27-30 STIP was reviewed with a focus on the Funding Categories, Timeline, Funding challenges, Federal Highway Formula Funding, the total gross State Highway Fund forecast as well as the ADA Curb Ramp Program.

Rail Safety – Chris Malm

- ➤ The Rail Safety and Regultory Branch is composed of four teams: FRA Inspection Team, Grade Crossing Safety Team, State Safety Oversight Team and the Walkway and Clearance Inspection Team
- Program funding comes from the gross revenue fee (GRF), Grade Crossing Protection Account, a Federal Transit Administration grant and Transportation Operating Fund
- ➤ There are ten (10) FTE with an additional two FRA-certified Highway-Rail Grade Crossing Inspectors
- ➤ The challenges facing the Grande Crossing Safety Team include the new requirement from UPRR and BNSF that the road authority involved in a crossing project to pay for annual maintenance costs
