Public input: Question was asked what the impact of not having HB3991 pass would look like for the area in which we live and reside in. Darrin Neavoll (ODOT) responded with it would have a significant impact to our Maintenance and Operations with approximately a 1/3 cut to budget. Which means a cut in our ability for winter maintenance to keep the roads open and clear.

Public input: question about improving Leigh Way in White city, at the intersection of Hwy 140 and HWY 62. Jeremiah was able to update and state that there in a plan in motion to improve the Leigh way turn lanes.

Discussion Items

A. CIP Presentation : 12:35 Presented by Amanda Pietz

Broke down details on how the investment and funds are distributed within ODOT. One thing that was addressed was how plans and projects are considered, and to develop improvements to the OTC and ODOT. Questions were raised to have those plans that ODOT is considering available to allow for discussion. Top 3-5 needs Reasonableness, Urgency, Regional and State wide benefit(s) and alignment with OTC investment priorities are key components to consider when presenting projects. Heat maps of traffic volumes, Safety needs, ped/bike needs, were asked to have available by meeting participants. Darrin stated he would find a way to get those provided to the next meeting to discuss how this committee or group can present (41:00 minutes)

B. Region and Budget update: 1:03:15 Presented by Darrin Neavoll and Jeremiah Griffin

Darrin provided agency updates, including the passing of the special session HB3991 and what that means for ODOT. Also explained how if a referendum is to happen what will happen with the passing of funds in the special session: should enough signatures be collected and accepted by the states Secretary of State Election Division all proposed fees and taxes would halt at the time of acceptance of signatures until it goes to vote in November 2026

Jeremiah presented on the goods that the HB3991 will do for winter operations and preparations, allowing us to not only hire temp/seasonal employees, but also provides OSP with additional coverage funds, where ODOT sees trucks not obeying the chain laws put in place for winter travel conditions.

C. ODOT Project Construction Update: 1:46:55 Presented by Mary Dillinger

Wrong Way Driver, Quick moving project, Gage-it Construction doing work. Tasks, applying low-cost treatments, such as reflectors, and updated signage.

Monument Drive to N. Grants Pass: pavement repair along I-5 in travel lanes, replacing bridge joints, removing hazardous guardrail and replacing said guardrail.

Allen Creek: modernization project, adding shoulders, sidewalks and other pedestrian amenities, please be

advised and follow single lane detour.

The Big X (OR238, OR99, and Hwy62) Replacing ADA ramps, updated road surface, multiuse path – this is not taking up a lane of travel and providing signal upgrades.

Foothill Road improvement: Local project with City of Medford, two lane road expanded. Continued work, that will be seen is work on the side of the road for culverts/ditches.

The Glenwood to Coleman project is part of the Alameda Fire rebuilding process. improving safety for pedestrians, Transit guests and cyclists.
