Key Takeaways

Tom Feeley, ODOT Resident Engineer provided an overview of Highway projects wrapping: (1) US 97, OR 58 to California border – complete summer (2025); (2) Brett Way/Homedale Roundabout – roundabout landscaping complete; and (3) U.S. 97 Bridge Deck Replacements – for the bridge over Hwy. 422 (Chiloquin) and the Shilo bridge (North Klamath) – complete summer (2025). (4) OR 140, Widening along Klamath Lake – project includes widening to 12' travel lanes w/ 6' should, along with curve correction and guard rail. Complete summer (2025). All projects are on schedule.

South Central Area Commission on Transportation has several transportation needs throughout the area (Lake & Klamath Counties), primarily related to vehicle and pedestrian safety, congestion relief, and freight mobility.

Agenda Notes

Chair Shullanberger presented and walked through the SCOACT priority spreadsheet, which highlights various transportation needs throughout the area. The list is meant to be a guide, and project

priorities may shuffle, or more projects may be added as SCOACT needs evolve. Funding still needs to be identified for many of the projects on the list.

ODOT Area Manager, Ben Ebner provided a presentation of ODOT projects in development, and projects under construction, along with slides showing future transportation priorities/needs identified by SCOACT. In the interest of time, emphasis was on Klamath County projects, whereas next SCOACT meeting will focus on Lake County Projects, with the December meeting combining both counties and setting overall South-Central Area priorities.

Election was held for SCOACT Vice Chair where Commissioner Andy Nichols was elected. He was unable to be present at the meeting but provided the green light to vote even with his absence. We will confirm the vote at the September meeting.
