Foster a culture of organizational change, as needed	Added commitment to continuous improvement
Funding	
Agree that funding is foundational and should be elevated	No change in SAP.
Strengthen language	Changed from "promote" to "secure" funding; and added more around stewardship of public funds – here & later
Safety	
Safety is critical issue and big priority; interest in hearing more	No change in SAP. Flagged safety for future OTC meeting
Add more on what we are doing	Added examples of ongoing efforts
Clarify our role and what we can do	Emphasized Safe System and what ODOT can influence
