**SUBJECT:** **I-205 NB and SB Multiple Ramp Closures (Clackamas)**

Beginning Sunday, July 5, 2020, there will be multiple intermittent on and off ramp closures from and to Interstate 205 in the Clackamas area. Ramp closures are scheduled Sunday through Thursday nights between the hours of 9 p.m. and 5 a.m.; Friday nights between the hours of 10 p.m. and 7 a.m.; and Saturday nights between the hours of 10 p.m. and 8 a.m. The estimated date of completion for this project is September 30, 2020.

The ramp closures are necessary for a pavement improvement project on I-205.



### **Detour Route Information:**

When ramps are closed, detour routing will be provided. Traffic will be routed to the nearest interchange by using other I-205 ramps. The detours are as follows:

When I-205 NB off-ramp to OR99E is closed, continue north on I-205, take Exit 10 to OR213 southbound; Washington Street; Clackamas River Drive; OR213 northbound; I-205 southbound, take exit 9 to OR99E

When the I-205 NB on-ramp from OR99E is closed, enter I-205 southbound, take exit 8 to OR43; I-205 northbound

When I-205 NB off-ramp to OR213 SB is closed, continue on I-205 northbound, take Exit 11 to 82<sup>nd</sup> Drive; enter I-205 southbound, take exit 10 to OR213 southbound

When I-205 NB on-ramp from OR213 is closed, enter I-205 southbound, take exit 9 to OR99E; I-205 northbound

When I-205 NB off-ramp to 82<sup>nd</sup> Drive is closed, take exit 12 to OR212; enter I-205 southbound, take exit 11 to 82<sup>nd</sup> Drive

When I-205 NB on-ramp from 82<sup>nd</sup> Drive is closed, enter I-205 southbound, take exit 10; OR213 southbound; Washington Street; Clackamas River Dr; OR213 northbound; I-205 northbound

When I-205 NB off-ramp to OR212 is closed, continue on I-205 northbound, take exit 13 to OR213 NB/OR224 WB; enter I-205 southbound, take exit 12B; OR212

When I-205 NB on-ramp from OR212/OR224 is closed, enter I-205 southbound, take exit 11 to 82<sup>nd</sup> Drive; I-205 northbound

When I-205 NB off-ramp to OR213 NB/OR224 WB is closed, continue on I-205 northbound, take exit 14 to Sunnybrook Blvd; I-205 southbound, take exit 13; OR224 WB/OR213 NB

When I-205 SB on-ramp from OR224 EB/OR213 SB is closed, enter I-205 northbound, take exit 14 to Sunnybrook Blvd; I-205 southbound

When I-205 SB off-ramp to OR212 WB/Webster Rd or to OR212 EB are closed, continue on I-205 southbound, take Exit 11 to 82<sup>nd</sup> Drive; enter I-205 northbound, take exit 12 to OR212

When I-205 SB on-ramp from OR212 is closed, enter I-205 northbound, take exit 14 to Sunnybrook Blvd; I-205 southbound

When I-205 SB off-ramp to 82<sup>nd</sup> Drive is closed, continue I-205 southbound, take exit 10 to OR213; I-205 northbound, take exit 11 to 82<sup>nd</sup> Drive

When I-205 SB on-ramp from 82<sup>nd</sup> Drive is closed, enter I-205 northbound, take exit 12 to OR212; enter I-205 southbound

When I-205 SB off-ramp to OR213 SB is closed, continue I-205 southbound, take exit 9 to OR99E; enter I-205 northbound, take exit 10 to OR213 southbound

When I-205 SB on-ramp from OR213 NB is closed, enter I-205 northbound, take exit 11 to 82<sup>nd</sup> Drive; enter I-205 southbound

When I-205 SB off-ramp to OR99E is closed, continue I-205 southbound, take exit 8 to OR43; enter I-205 northbound, take exit 9 to OR99E

You choose the information you are interested in receiving, and it will come right to your electronic mailbox. In addition to the restriction letters, ODOT offers subscribers more than 50 specialized email alerts for information like trucking advisories, Oregon Motor Carrier Newsletter, Motor Carrier rulemaking, Motor Carrier Transportation Advisory Committee Meeting Notices/Minutes, etc.
