This booklet has been prepared by the Commerce and Compliance Division of the Oregon Department of Transportation. Included herein are the most common violations that pertain to commercial motor vehicle highway operations.

Violations shown in *Bold* are classified as Misdemeanors, all others are Traffic Violations.

If the officer issuing the citation notes on the citation the offense occurred in a highway work or school zone the presumptive fine amount entered on the citation shall be taken from the Work or School Zone column shown on the inside back cover.






