November 19, 2024

## Subject: Placing Vehicles and/or Drivers OOS When Transporting Sensitive Commodities Including Livestock



**Before inspecting vehicles/drivers transporting agricultural commodities or on behalf of a farmer, ensure that they are not otherwise exempt from inspection.**

If you conduct an inspection resulting in a driver and/or vehicle OOS, further action is required on your part.

Refer to CVSA Operational Policy 5 which requires that Motor Carrier's be notified of a vehicle or driver OOS in specific situations.
