## **ADDITIONAL INFORMATION:**

- Tower zones defined as: Zone A= 0'-49', Zone B= 50'-89', Zone C= 90'-129', Zone D=130' +
- Rental rates for dishes larger than 10' will be negotiated on a site by site basis.
- Rental rates for panel antennas, solar panels, shelving, floor space, etc. will be determined after it is known what equipment is proposed to be installed.
- A non-refundable application fee of up to \$1,500.00 may be charged at ODOT's discretion.
- Lessee will be responsible to obtain, at their expense, any studies required to collocate on the site which must be reviewed and approved by ODOT/WCS.
- These rates are for 2024 and will typically escalate 3% annually to be effective on January 1<sup>st</sup> of each year.
- These rates are to provide a general estimate and may vary from site to site. The exact rate will be determined prior to finalizing the agreement.
