# Upcoming Pre-Construction Activities

The Oregon Department of Transportation will demolish two buildings and remove two signs to build safety improvements for Phase 2 of the **Outer Powell Transportation Safety Project**. When completed, the project will help people travel Outer SE Powell Boulevard more safely by adding a center turn lane, sidewalks and bike lanes.

Before roadway construction begins along the corridor in spring 2023, demolition and sign removal will occur at these locations:

- **Smoker's Zone Building** at 15400 SE Powell Blvd.
- **Exodus Building** at 16211 SE Powell Blvd.
- **Drive-in Movie Sign** at SE 108th Ave and SE Powell Blvd.
- **Shell Station Sign** at SE 164th Ave and SE Powell Blvd.

Work is expected to begin **December 2022**, with work occurring Monday through Saturday, from 7 a.m. to 6 p.m.

*Schedule is subject to change based on weather and site conditions.*



## Pre-Construction Impacts

This work will include **periodic travel lane, bike lane, sidewalk and parking closures with detours and temporary pedestrian access routes.**

## Noise Impacts

Those working or living in the area may hear **noise** from demolition equipment, construction trucks and beeping noises when vehicles are in reverse.
