

OR 99E at Maple Street Pedestrian Improvements



About

We are building an enhanced crossing on OR 99E at SE Maple Street. The project installs an overhead RRFB, a pedestrian refuge island median, ADA compliant curb ramps with push buttons, illumination and speed feedback signs (one mile north).

Pedestrian activated beacons can reduce crashes between vehicles and pedestrians by up to 47% according to the Federal Highway Administration.

Project Need

ODOT worked with community to get input and identify this location as a priority site for pedestrian safety improvements. As it is now, pedestrians have to travel nearly a half-mile out-of-direction just to use the nearest marked crossing.

This project improves pedestrian safety on OR 99E by installing a pedestrian activated beacon.

Project Cost

Project cost is being developed and is being paid for by Statewide Pedestrian and Bicycle Program Funds.

Project Schedule

Construction expected October - December 2024.

During construction, travelers can expect lane closures on OR 99E and impacts to SE Maple and Chestnut Streets including turning restrictions and detours.
