# Upcoming Pre-Construction Activities

The Oregon Department of Transportation (ODOT) is gearing up to begin pre-construction activities for the **Outer Powell Transportation Safety Project**. The project will help people travel Outer SE Powell Boulevard more safely. The first phase, from SE 122nd Avenue to SE 136th Avenue, is complete. Road construction for the second phase, from SE 99th Avenue to SE 122nd Avenue and SE 136th Avenue to just east of SE 174th Avenue (the Portland/Gresham city limits) is anticipated to begin spring 2023. The overall Outer Powell Project will add a center turn lane, sidewalks and bike lanes. Before construction begins along the corridor, pre-construction activities, such as utility pole relocation in addition to tree trimming or tree removal must occur in some areas. This work will take place between **October 2022 and February 2023**. To minimize traffic impacts, daytime work will occur from 9:00 a.m. to 3:00 p.m. and nighttime work will occur from 9:00 p.m. to 5:00 a.m. *Schedule is subject to change based on weather and site conditions.*



## Pre-Construction Impacts

This work will include **periodic travel lane, bike lane, shoulder, sidewalk closures with detours and temporary pedestrian access routes.**

## Noise Impacts

Those working or living in the area may hear **noise** from heavy equipment, construction trucks, beeping noises when vehicles are in reverse and other equipment **related to pre-construction work.**
