Background

The Rural Veterans Healthcare Transportation (RVHT) Grant Program was created by Senate Bill 5538 (SB 5538) during the 2019 Oregon Legislative Session. The purpose of this program is to serve the transit-related needs of veterans living in rural areas, including access to physical, mental, and/or behavioral healthcare. In the winter of 2019, the Oregon Department of Veterans' Affairs (ODVA) invited the Oregon Department of Transportation's (ODOT) Public Transportation Division (PTD) to develop and implement RVHT via its network of public transit providers.

Through two rapid-response solicitations, the RVHT partnership made awards serving ten rural markets and funded a project of statewide significance that provided targeted outreach efforts and created a veterans-only carpool matching website utilizing software from ODOT's GetThere vendor Ride Amigos. In the spring of 2021, ODVA approved PTD's recommendation to extend the original projects (in consideration of the impact and challenges of the global COVID-19 pandemic) through December 31, 2021.

During its 2021 session, Oregon's Legislature passed House Bill 2139 (HB 2139), formally codifying the RVHT program in statute. HB 2139 is materially similar to the original RVHT pilot with two key differences:

- A. While the Bill itself does not stipulate a budget, an appropriation of \$650,000 was approved. This represents a 30% increase relative to the \$500,000 investment made under SB 5538.
- B. HB 2139 does not exclude areas receiving support under the Highly Rural Veterans Transportation Grant Program offered by the U.S. Department of Veterans' Affairs.



Please note: HB 2139 explicitly continues ODVA and PTD's original stipulation that all nine of Oregon's federally-recognized Tribes are categorically eligible RVHT recipients, irrespective of the rurality of the area in which they are located.

Special Transportation Fund Discretionary Program

Consistent with the pilot round of funding, PTD is offering RVHT through the Special Transportation Fund (STF) Discretionary Program. In addition to providing legal authority (at least through the 2021 – 2023 biennium) to administer the project, the STF Discretionary Program offers a familiar framework for PTD and STF Agencies.

Eligibility

For Providers:

A transportation provider is eligible to apply for an award under the RVHT program if it is eligible for the STF Discretionary Grant Program and the area to be served has been assigned a Rural-Urban Commuting Area (RUCA) code of 4 through 10, as determined by the U.S. Department of Agriculture, as of July 3, 2019 (see Appendix A). Please note, HB 2139 extends eligibility to those areas that were excluded in the pilot funding round due to the presence of a Highly Rural Veterans Transportation Program grant by the U.S. Department of Veterans' Affairs.

Oregon's federally recognized Indian Tribes are eligible to apply irrespective of RUCA coding.

For Passengers:

The term "veteran" will follow the definitions established in ORS 408.225(1)(f), governing eligibility for preference in public employment. Public transit providers receiving funding under the RVHT program are encouraged to incorporate the statute by reference into their process for identifying veterans and recording/reporting their ride statistics.

Goals, Objectives, and Priorities

The goal of the RVHT Program is to overcome transit-based barriers between veterans living in rural areas and the healthcare services they've earned. RVHT's objective is to inspire innovative local solutions to transit challenges such as:

- Lifeline transit service in bedroom communities;

- Schedules and frequencies that conform to veteran's needs;
- Appointments with out-of-market specialists and regional veterans hospitals;
- Ongoing appointments for the treatment of chronic conditions;
- Access to behavioral health services, counseling, and support groups;
- Periodic service to screening, detection, diagnosis, and disease prevention events; and
- Accessible transit for veterans living with disabilities.

The RVHT Program prioritizes projects with clearly identified needs and solutions that are efficient, effective, and measurable. Anticipated outcomes should be appropriate in scope and scale to the budget and time frame of a grant award. To the maximum extent practicable, proposals should demonstrate coordination of transportation services and resources.

Please note: applicants are encouraged to think very broadly about the definition of *healthcare facilities* and related destinations. It is not necessary for a veteran to access a facility funded or operated by the U.S. Department of Veterans' Affairs to qualify for transit services under this program. Moreover, access to goods and services that contribute to a veteran's well-being should be accommodated. These may include (but not be limited to or limited by): community and walk-in clinics, including those staffed by nurse practitioners and/or in proximity to other destinations such as major retailers; vision services, including vision retailers; dentists and denturists; audiology and hearing aid clinics/retailers; physical or occupational therapists; pharmacies and durable medical equipment vendors; smoking cessation and weight loss services; palliative care; and alternative/cultural medical services.

Project Types and Eligible Use

This solicitation will prioritize proposals for operations and purchased services. These project types will minimize the recipient's reporting and create (or preserve) immediate benefits for veterans.

Mobility management and planning projects are eligible but the burden is on the applicant to demonstrate how the proposed investment will meaningfully and measurably improve healthcare access for rural veterans.

Applicants are encouraged to think holistically about the scope of service necessary to be successful and to allow for these expenditures in their proposed project budgets. Veterans Services Officers (please see Appendix C) and staff at veterans' medical facilities (please see Appendix D) are key allied professionals in building local awareness of RVHT services.

One example of a successful program utilizing this holistic approach is the Go Vets Program developed by Rogue Valley Transportation District. This program teaches veterans about possible travel options and connects them with local resources and services needed to sustain a happy and healthy life. . A toolkit is available online and this program can be duplicated or used a resource for new ideas.

Shared Rides, Costs, and Fares

RVHT seeks to serve the highest volume of veterans possible within available resources. Service to veterans in a shared ride mode is encouraged (including with general public passengers sharing common origins, destinations, or routes). **However, the absence of a shared ride option is not a sufficient reason to decline a veteran's travel request for an otherwise eligible trip.**

RVHT is limited to the fully allocated cost of serving veterans. Incidental civilian costs from shared rides are ineligible. While the following examples are not exhaustive, they may provide helpful illustrations of the expenses that are reimbursable under RVHT:

Generic shared ride trip: A simple method to estimate eligible RVHT costs for a veteran using a local fixed route or demand response system can be calculated by dividing total expenses by total rides in the previous fiscal year. This figure represents the fully allocated cost of a trip. RVHT would expect to pay no more than this figure, per served veteran ride.

Special out-of-market, shared ride trip: A trip that leaves the local area imposes costs beyond the generic ride described above (and therefore requires a different expense model). In these cases, it may be appropriate to apply fully allocated cost per mile or fully allocated cost per hour – whichever the provider chooses to employ with consistency. RVHT would expect to pay the fully allocated cost of the veterans involved in this trip. For example, for a four hour trip at \$100/Revenue Service Hour, shared by three veterans and one civilian, RVHT would expect to pay \$300.

Dedicated Trip: From time to time, circumstances may arise when the shared ride preference for RVHT will be a poor fit. For example, a veteran may need to travel out of market for care to places (or on days, or at times) when no shared ride demand exists. Alternatively, the unique conditions of a veteran's care needs may make a dedicated driver and vehicle the compelling choice. In these cases, RVHT would expect to pay the full cost of delivering the trip. For convenience of consistently calculating these costs, providers may wish to use the cost per hour or cost per mile methods described above.

Veterans (and their Personal Care Attendants) may not be charged a fare, co-pay, or other fee for using these services. A veteran may make a donation to providers that are structured to receive them. However, a provider shall not ask for or otherwise solicit a donation from RVHT passengers.

General Project Requirements

Pursuant to the crosscutting requirements of the STF Discretionary Program, proposed projects must be supported by a locally-adopted Coordinated Human Services Public Transportation Plan. Consistent with traditional STF Discretionary processes, the STF Agency will evaluate local submissions through its STF Advisory Committee and will prioritize the projects it submits accordingly. PTD will distribute RVHT awards through a discretionary selection process.

Funding Estimate and Local Match

PTD intends to award up to \$650,000 under this solicitation. No local match is required from funding recipients. Conversely, an RVHT award may be eligible for use as local match funding in complementary transit efforts. Please consult with your Regional Transit Coordinator if you are unsure (please see Appendix B – Key PTD Staff).

PTD anticipates making 10 to 15 grant awards, between \$35,000 and \$75,000. This estimate has been developed for your ease of reference and to facilitate resource forecasting. The Project Scoring and Selection Committee will consider each project based on its merits. Actual results may vary based on the number, quality, and scalability of applications received. The minimum request accepted by the online application is set to \$10,000; there is no maximum. Applicants are encouraged to **ask for what the project needs**. Projects should feature a realistic budget and manageable outcomes for an 18 month endeavor.

Coordination

ODVA and PTD recognize that for some STF Agencies, the available funding may not be sufficient to create and implement a new program. In such cases, STF Agencies are strongly encouraged to coordinate with nearby STF Agencies to submit joint-funded and mutually-beneficial proposals.

Alternatively, neighboring STF Agencies may realize fiscal and operational efficiencies by proposing individual contract purchased services projects that coordinate through a mutual service provider.

STF Agencies adjacent to those applying for ongoing RVHT projects or those receiving Highly Rural Veterans Transportation support from the U.S. Department of Veterans' Affairs are encouraged to explore expansion opportunities that mutually leverage the available resources and capacities.

Continuity of Existing Projects

Projects funded under the pilot rounds of RVHT were extended through December 31, 2021. Per HB 2139, PTD intends to work with any provider recommended for ongoing funding in this next round of project selection to preserve services already in place under 2019-21 awards. Alternatives to preserve continuity of service may include amending existing agreements to avoid a funding gap, or, when appropriate, granting pre-award authority expenditures incurred between January 2022 and April 2022. PTD may likewise consider granting pre-award authority to new start projects on a case-by-case basis, for services that begin prior to agreement execution. In any case, eligibility for reimbursement under this solicitation will not begin prior to January 1, 2022.

Please note, PTD and ODVA understand the challenges involved with rolling out a new service during a global pandemic. This data point is intended to help the Committee make a longer term recommendation to ODVA, PTD, and OTC about proportioning future resources into categories for preservation vs. expansion and new service opportunities.

PTD anticipates awarding 10 to 15 projects, between \$35,000 and \$75,000, for delivery between 02/01/2022 and 06/30/2023. However, this estimate was developed for forecasting convenience. The Scoring and Selection Committee will evaluate each project based on its merits – it is not bound to this award range.

Given the work generated by each award, PTD does not typically develop grant agreements for less than \$10,000 – which constitutes the lowest value the application form will accept. There is no upper restriction; applicants are encouraged to ask for the amount a project needs to be viable.

Box A is for the amount of funding that an applicant wishes for the Committee to consider if the project is funded in full. It is the only one of the fields shown above that is required.

Sometimes, a project that would be incredible if we could afford it can still be great (and competitive) if it's possible for us to grow into it. If your proposal can be scaled back to a leaner version, please indicate the minimum award that would make it viable in Box B. Often, new services are an all-or-nothing-proposition. If that describes your project, leave Box B. blank.

The RVHT program does not require local match (at least, not in this cycle). However, Box C. has been added from Scoring and Selection Committee feedback in the previous cycle. If you plan to invest resources beyond your RVHT request, indicating it on the application will give the Committee an important sense of context. Without it, answers you provide to the following questions may seem unrealistic relative to the amount of money you’ve asked for. With that in mind, Box C. is not a required element of the application.

Planning and Purchased Services Conditional Fields Required/Not Scored

If you selected *Planning* from the Project Type dropdown box, you’ll be prompted with a field that asks if you intend to engage a consultant. If you select *Yes*, another field will appear that asks you to estimate the % of the project award you anticipate spending on consulting services.

You are not required to use a consultant if you are awarded a Planning grant under RVHT. This section provides a sense of context for the Scoring and Selection Committee. An agency without a great deal of administrative capacity or experience with planning projects may be able to successfully deliver an ambitious project if it opts to engage a consultant. Another agency with on-staff planning talent may not **need** to hire a consultant but may choose to in any case to augment its capacity.

Competitively Scored Responses:

In contrast to the preceding content, answers to the following questions will be competitively scored. In each case, narrative responses have been limited to 2,000 characters. All four general inquiry categories (Project Description, Project Need, Outreach, and Veteran Outcomes) will be evaluated at equal weight – that is, each category accounts for 25% of the applicant response score total. In addition to this criteria, the members of the Scoring and Selection Committee are empowered to award up to ten total points for

factors such as the completeness and credibility of the application, a sense that deliverables that are proportionate to the project budget, and the quality of attached supporting documents.

Applicants are encouraged to review the guidance in italic print that has been offered on the application below most of the questions that will be scored. These are examples of things the Scoring and Selection Committee will be looking for. The following guidance points may also be useful.

<u>Project Description</u>	Required/ Scored

The Project Description should be sufficiently detailed to convey what the project will do and how it will expand upon what is already available for veterans in the service area. Strong answers provide a sense of what a veteran will be able to do in the future as a result of the requested investment. Answers that only describe benefits transit would likely provide even if the proposal isn't funded haven't historically scored as well. If your proposed service will help a veteran make a connection to another transportation service or community, please share a few details in your response.

Please describe the project need in the area you are proposing to serve. Be specific and measurable wherever possible. If you don't have something empirical to share, describe what a day-in-the-life of someone trying to overcome the local mobility challenge may look like. Ride Coaching for this project is defined as introducing a passenger to the aspects of Rural Veterans Healthcare Transportation and/or general public transit system that are fundamental to using the service. Examples include how to schedule a ride, where to catch a bus, how to request and use a transfer, how to read a timetable, and where to call for assistance. While call taking and ride scheduling may be components of a Ride Coaching session, they are not sufficient on their own to count against this measure.

Travel Training for this project is defined as the practice of providing a knowledgeable, hands-on staff member or volunteer to act as a travel companion that introduces the Veteran to RVHT program and/or transit system. The Ride Coaching and Travel Training fields will appear if you've selected *Mobility Management* from the Project Type dropdown box. Sometimes, PTD receives an application for Mobility Management that only describe activities associated with call-taking and ride scheduling. While these important functions can be contributing components of Mobility Management when delivered by a skilled staff member, on their own they're just considered dispatch (which is an Operations, not a Mobility Management project). Appendix A: RUCA Coding

Rural-Urban Commuter Area (RUCA) Coding is a population density and travel orientation methodology developed by the United States Department of Agriculture and the Department of Health and Human Services. This census-tract-based approach is utilized by the United States Department of Veterans' Affairs (VA) to determine rurality. In addition to compatibility with the standard used by the VA, RUCA provides this project with an effective tool to determine eligibility for veterans residing in areas that may be ineligible if we only considered the rurality of their county. For example, please consider

County X:

County X is rural by almost any metric you wish to consider. Its largest city is home to less than 15,000 people. However, one of Oregon's metropolitan communities has been growing across its boarder for the last few decades. A strict county-based definition of rurality may unfairly leave County X classified as ineligible.

County Y:

County Y is geographically large and diverse. Outside of one of Oregon's major metropolitan areas that call it home, there is only one community approaching 10,000 people. There are in fact, over 80 unincorporated communities within its borders. The coastal area of County Y comes up consistently in the veteran's healthcare access conversation as a place where more access services are needed. However, due to an urban area that's a 90-minute drive away, these populations would be ineligible if we applied a county-based population threshold on RVHT.

Primary RUCA coding breaks census tracts down as follows (paraphrasing for ease of understanding and reference):

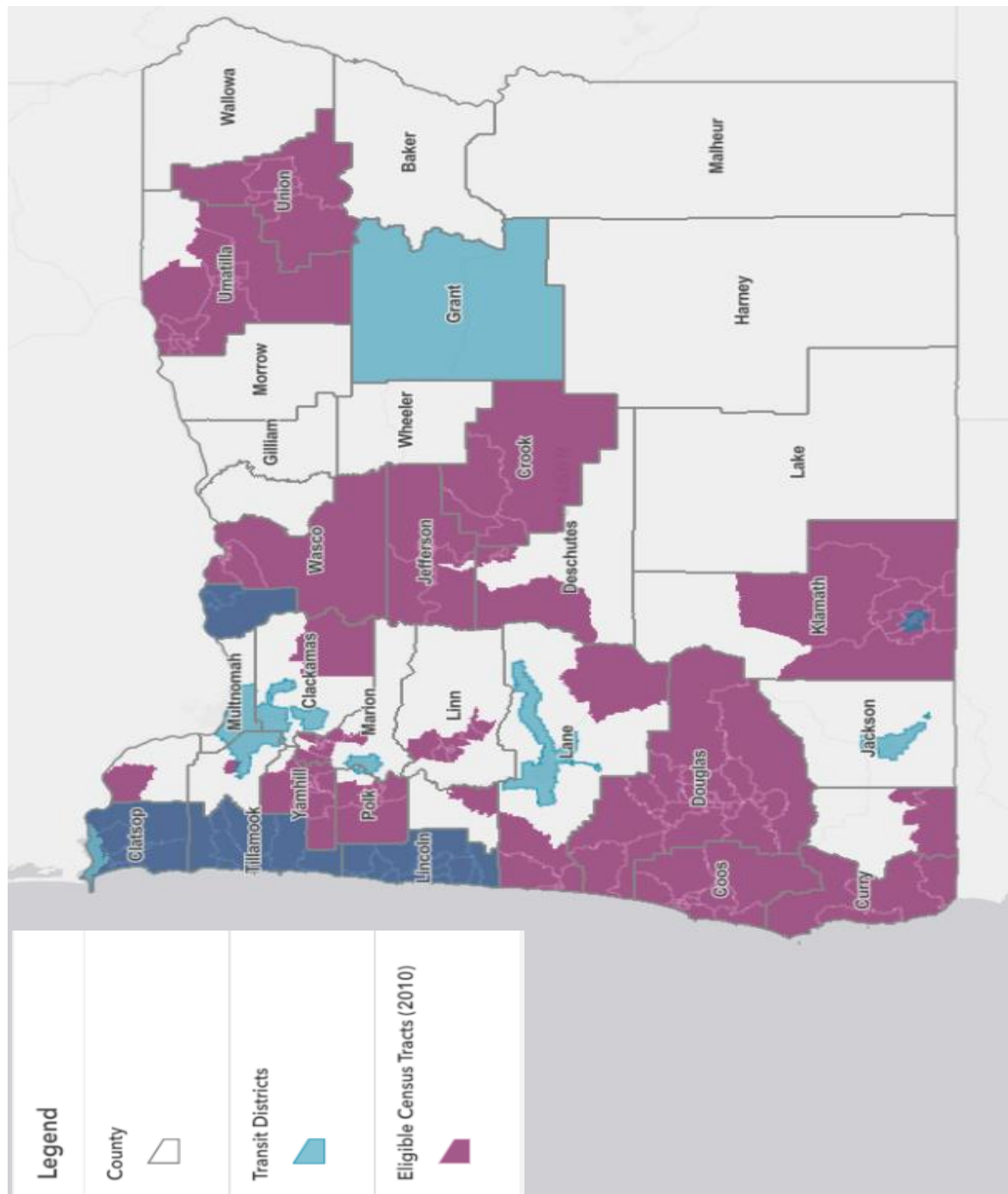
- 1 – 3 Metro areas (over 50,000 people) with varying levels of primary traffic flow moving between them;
- 4 – 6 Micropolitan areas (10,000 to 49,999 people) with varying levels of primary traffic flow moving within or between an urbanized area.
- 7 – 9 Small town areas (2,500 to 9,999 people) with varying levels of primary traffic flow toward micropolitan or other small town areas.
- 10 Rural areas with primary flow of traffic to a census tract outside the classifications above.

The RVHT Grant Program funds STF Agencies on the basis of the presence of census tracts classified by RUCA codes 4 through 10. Veterans living within such a tract are eligible to receive the benefit of these services even if the county (as in the examples above) may otherwise not qualify. In addition to RUCA codes, PTD considered the number of veterans residing in eligible census tracts and the number of eligible applicants to develop its distribution model.
