RVTD does not have a suballocation method in place due to their being only two PTASP's in the area who work cooperatively using an application each biennium. Two other providers qualify for the STIF Population funds. Solicitation materials to apply for consideration of receiving STIF funds were posted to the www.rvtd.org website in addition to be being sent electronically to agencies and organizations who have received STIF funds previously. Applications were reviewed by the STIFAC and their workgroup and awards were recommended to be considered by the RVTD Board of Directors.
