Yamhill County as the Qualified Entity followed its bylaws for STIF Formula Fund moneys and a collaborative process to allocate STIF funds. The STIF Advisory Committee is the Yamhill County Transit Advisory Committee. They advise the Board of Commissioners on the development process and adoption of the STIF plan. Public notices were printed in local newspapers for all STIF related YCTAC/BOC meetings and to seek sub-provider applications. The applications were due on Dec 12, 2024. Three sub-provider projects are included in the 25-27 STIF plan. YCTAC reviewed and prioritized projects proposed for inclusion in the 25-27 STIF Plan with funding amounts for each project. YCTAC met December 19, 2024, and January 14, 2025, and approved and recommended to the QE/Board of Commissioners to approve the 25-27 STIF plan at their meeting on January 16, 2025.

The determination of high-percentage of low-income population (households) is based on the 200% of poverty population (share of population for whom poverty status is determined), which is 25% for Yamhill

County overall (based on 2023 ACS 5-Year Estimates). The following Yamhill County cities are defined as having a high percentage of low-income households, based on a share of the population earning at or below 200% of poverty guidelines that is equal to or higher than the countywide average: Willamina (39%), Sheridan (35%), McMinnville (33%), Dayton (31%), Amity (33%). Lafayette (24.5%) is slightly below the threshold. All YCT routes are determined to serve a high percentage of low-income households based on the share of low-income population within 1/2 mile of the route.
