## 2024 - 2027 STIP Safety Programs

There are three programs under Safety with differing selection criteria:

- All Roads Transportation Safety (ARTS) For safety projects on all public roads (includes both ODOT and Local Agency selected projects)
- House Bill 2017 Safety (HB2017 Safety) State funds to address high-priority needs on ODOT Highway system
- Rail Safety For highway/rail crossing improvements that improve safety

Region 1 will manage \$28.4 million in designated funds for ARTS and \$9 million in funds for the HB2017 Safety program. The Rail Safety funds are managed as a statewide program. Project selection prioritization is different for each of the safety programs but scoping and final programming is coordinated between program managers and region leadership.
