Interstate 5 – Pacific Highway – I-5 Rose Quarter Improvement Project

Project Description: We are improving safety and congestion where I-5, I-84 and I-405 converge and reconnecting the Albina neighborhood by constructing a highway cover over a portion of I-5.

From summer 2025 through late 2026, we are constructing new stormwater facilities, repairing the concrete deck in a section of I-5, completing a seismic retrofit, extending an existing merging lane on SB I-5 and constructing a new sign structure.

Traffic Impacts: Overnight lane and ramp closures.

Overnight right lane closures of I-5 southbound between Moda Center and Morrison Bridge on August 10-14 from 10 p.m. to 5 a.m. each night for replacement of bridge railing.

Overnight off-ramp closure from I-5 southbound to I-84 Eastbound (Exit 301) from 10 p.m. to 5 a.m. on August 10-14 for updates to the bridge railing and concrete pours.

Interstate 84 – Columbia River Highway – McCord Creek Bridge 25T021517

Project Description: We are replacing the aging bridge that carries I-84 east over McCord Creek near Warrendale in 2025-2026. Replacing the bridge will eliminate a dip in the roadway and increase safety, earthquake resilience, and the lifespan of the highway.

Traffic impacts: Travelers can expect around the clock eastbound and westbound lane closures on I-84 at McCord Creek Bridge.

There will be one lane open in each direction with traffic control crossing over the median. The I-84 onramp at NE Frontage Road is closed.

Interstate 84: (Multi-Use Path) Jordan Road Tunnel - Sandy River (26T005569)

Project Description: We're building a new multi-use path parallel to Jordan Road (near I-84 at Exit 18) from the pedestrian tunnel under I-84 to the Sandy River Delta, increasing safer connections for people who walk, bike or roll.

Traffic Impacts: Daytime periodic lane closures on Jordan Road, with flaggers directing traffic.

Interstate 84 - I-5 to Hood River All Roads Transportation Safety (ARTS)

Project (26T005562, 26T005563)

Project Description: We're improving safety and visibility at multiple I-84 interchange ramps between downtown Portland and Hood River by installing new lights, upgrading traffic signal heads, trimming overgrown vegetation and upgrading existing signs through fall 2026.

Traffic Impacts: Lane closures and flagging at night on I-84 ramps at 122nd and 60th. Travelers can expect parking restrictions in the area.

Interstate 205 - East Portland Freeway –Columbia River - 82nd 26T028057

Project Description: ODOT is improving safety at ramp intersections along I-205 between the Columbia River and SE 82nd Drive improving signals, lighting, striping and updating signs.

Traffic Impacts: Nighttime flagging at ramps on I-205 between SE 82nd and Oatfield.

Interstate 205 – East Portland Freeway – Improvements Project Phase 1A Abernethy Bridge (22T046983)

Project Description: The I-205 Improvements Project is upgrading the Abernethy Bridge — a critical link on I-205 connecting West Linn and Oregon City — to withstand a major earthquake. We are also realigning I-205 interchanges at OR 43 and OR 99E, making safety improvements for people biking, walking and rolling and building a new sound wall in Oregon City.

Traffic Impacts: Nighttime closures of I-205 northbound, lane and ramp closures on I-205, OR 43 and OR 99E in Oregon City and West Linn.

- **A southbound closure of I-205 across the Abernethy Bridge is planned for Friday and Saturday night, August 14th and August 15th from 11:00 pm to 7:00 am. The OR 99E on-ramp to I-205 southbound and the I-205 Southbound Off-ramp Exit 8 to OR43 will also close.**

Nighttime lane closures

- I-205 Northbound – Monday through Thursday from 10:00 pm to 5:00 am.
- Willamette Falls Drive Right Lane Closure - Monday to Tuesday 8:00 pm to 6:00 am.
- OR43 Southbound - Monday to Thursday 8:00 pm to 6:00 am.

Nighttime ramp closures

- Nighttime ramp closure from to OR99E On-ramp to I-205 Southbound - Friday and Saturday from 10:00 pm to 7:00 am.
- Nighttime ramp closure from OR43 to I-205 Northbound – Monday through Thursday from 10:00 pm to 5:00 am.
- Nighttime ramp closure from I-205 Southbound to OR43 – Monday through Thursday from 10:00 pm to 5:00 am and Friday and Saturday from 11:00 pm to 7:00 am.

Nighttime ramp closure from I-205 Northbound to OR99E (Exit 9) –Thursday from 10:00 pm to 5:00 am.

U.S. 26 – Powell Boulevard – Outer Powell Transportation Safety Project (22T075374)

Project Description: We are constructing safety improvements to help people travel Outer SE Powell Boulevard more safely from SE 99th Avenue to SE 122nd Avenue and SE 136th Avenue to just east of SE 174th Avenue (the Portland/Gresham city limits). The first phase, from SE 122nd Avenue to SE 136th Avenue, is complete.

The overall Outer Powell Project will add a center turn lane, sidewalks and bike lanes. These improvements reduce the frequency and severity of crashes as well as help people driving, taking

transit, walking and biking share the road with fewer conflicts. Road construction began in spring 2025 and is planned for five years.

Traffic Impacts: Lane closures, traffic shifts, shoulder closures and up to 20-minute traffic holds 8 a.m. to 5 p.m., weekdays. Temporary sidewalk closures with accessible pedestrian detours.

Possible nighttime work with closures. Travelers can expect congestion during construction. Alternate routes are available. Flaggers may be directing traffic.

U.S. 30 BY – NE 42nd Avenue Bridge Replacement (26T050952)

Project Description: Closures are required for PBOT's [NE 42nd Avenue Bridge Replacement](#), which will make a seismically safe crossing for an emergency route and provide better access for freight, pedestrians, and people biking on the bridge and NE Lombard Street below the span.

Traffic Impacts: NE Lombard Street reduced to one lane in each direction for the duration of the bridge construction

U.S. 30 BY – Bridge over Private Drive (26T028034)

Project Description: This project restores the bridge on NW Bridge Ave. northwest of the St. Johns Bridge, connecting to U.S. 30.

Traffic Impacts: No traffic impacts

U.S. 30 BY – St. Johns Bridge – Bridge Repair (22T088503)

Project Description: We are improving the long-term safety and lifespan of the St. Johns Bridge by repairing the concrete on the pier columns and arches under the bridge. Repairing the concrete will protect the bridge's steel internal frame and reinforcements from corrosion, maintaining the service life of this beloved Portland Historic Landmark.

Traffic Impacts: No traffic impacts.

OR 8 – TV Highway – Pedestrian improvement project in Hillsboro and Forest Grove (26T029640)

Project Description: This safety improvement project in three locations on OR 8 in Hillsboro and Forest Grove includes new sidewalks, an enhanced pedestrian crosswalk, new lighting and upgraded traffic signals.

Traffic Impacts: The right lane of OR 8/SW Baseline Street in Hillsboro is closed 24/7 between SW Dennis Avenue and SW Main Street.

OR 8 – Canyon Road – Pedestrian improvement project in Central Beaverton (25T104181)

Project Description: This partnership project between ODOT, City of Beaverton and Metro will improve pedestrian safety on SW Canyon Road (OR 8) from SW Hall Boulevard to SW Cedar Hills Boulevard in Central Beaverton by adding two new crosswalks, a flashing beacon, new lighting and a landscaped center median.

Traffic Impacts: No travel impacts.

OR 127 Cornelius Pass – Cornelius Pass Hwy & U.S. 30 ITS Improvement

Project Description: The Cornelius Pass Hwy & U.S. 30 ITS Improvements Project focuses on making Cornelius Pass Highway (Highway 127), between U.S. 26 and U.S. 30, safer and more efficient for travelers. The project includes upgrades to lighting, signal equipment, and signage, as well as new intelligent transportation system (ITS) devices such as traffic cameras, variable message signs, and an activated intersection warning system, bringing it up to the latest Oregon Department of Transportation (ODOT) standards.

Traffic impacts: Shoulder closures on U.S. 30 at Skyline Blvd.

OR 127 – Cornelius Pass Road – Rock Creek Bridge Replacement (26T051419)

Project Description: In partnership with Washington County, we are replacing the bridge over Rock Creek on Cornelius Pass Road, north of Germantown Road

Traffic Impacts: Cornelius Pass Road is currently closed at the Rock Creek Bridge between Old Cornelius Pass Road and Kaiser Road through September 29. A signed detour is in place.

OR 141 – Hall Boulevard - SW Fanno Creek Trail and SW Omara Street Pedestrian Improvements Project (26T052912, 26T052913)

Project Description: We're improving safety for people walking, biking or rolling by installing a new pedestrian-activated crossing, known as a Rectangular Rapid Flashing Beacon, on Hall

Boulevard (OR 141) at SW Omara Street and upgrading the existing signalized crosswalk at SW Fanno Creek Trail.

Traffic Impacts: Shoulder closures with traffic pattern changes Monday – Friday between the hours of 9:00 am to 3:00 pm.

OR 141 – Boones Ferry Road – rail maintenance (26T062906)

Project Description: Portland & Western Railroad is doing rail maintenance on the railroad tracks on SW Boones Ferry Road between SW Lower Boones Ferry Road and the Tualatin River in Tualatin/Durham.

Traffic Impacts: SW Boones Ferry Road is closed 24/7 at the railroad crossing between SW Lower Boones Ferry Road and the Tualatin River from Monday through Thursday, Aug. 10-13. A shuttle is available around-the-clock to transport pedestrians around the detour. Local access will remain open.

OR 224 – SE 17th Ave and Rusk Rd

Project description: ODOT is improving safety, paving between SE 17th Avenue and SE 37th Avenue and performing bridge improvements to OR 224 between SE 17th Ave and Rusk Rd.

Traffic impacts: Lane and ramp closures on OR 224 in Milwaukie. Sidewalk closures with accessible pedestrian detours.

Various Highways – ADA curb ramp construction (Phases 1, 2, 3, 6, Sandy/Molalla)

Project Description: We are bringing over 1,100 sidewalk curb ramps into compliance with Americans with Disabilities Act (ADA) accessibility standards on various highways in Region 1.

Traffic Impacts: Lane and sidewalk closures throughout the Portland-metro area for ADA curb ramp work.
