### Call to Order and Introductions:

**Vice Chair Cate Duke** opened the meeting at 9:01 a.m. She welcomed attendees and acknowledged both in-person and virtual participants. She led a moment of silence to remember those who have been killed or seriously injured in crashes involving an impaired driver.

### Vice-Chair Report:

**Vice Chair Duke** shared updates from her new role in Prineville and noted a high volume of DUII cases in her jurisdiction.

### Member Reports:

**Justin Nielsen** shared his concern over lack of communication from OHA regarding ASAM 4<sup>th</sup> Edition implementation.

**Deborah Ruiz** highlighted the opening of a new [CATT Program in Washington County](#). She plans to tour facilities and update provider information.

**Lois Harvick** shared updates on volunteer-led victim impact panels. Her organization is undergoing some rebranding and digital outreach efforts.

**Sarah Gold** piggybacked on Deborah's report and noted new treatment facilities in Hillsboro and Beaverton.

**Tim Plummer** has officially retired, but remains active at-large with the IACP and the GAC.

**Lynn Howard** shared a recent sentencing update on a [Southern Oregon DUII fatal crash](#). The Tree of Remembrance is scheduled for December 9.

### Minutes of Previous Meeting:

**Vice-Chair Duke** asked if there were any changes to the [October 2025 GAC DUII meeting minutes](#). None were noted.

**MOTION:** Justin Nielsen moved to approve the October 2025 GAC-DUII meeting minutes. Sarah Gold and Deborah Ruiz seconded. Roll call vote: APPROVED.

### Transportation Safety Office (TSO) Report:

**Ryan Stone** shared [preliminary crash data](#); motorcycle fatalities are down 29%, overall motor vehicle fatalities are down 12%, with pedestrian and micromobility incidents increasing. Concerns were discussed about impaired operation of e-bikes and scooters. TSO has officially moved from under DMV to become part of Policy, Data, and Analysis (PDAD); recruitment is underway for the new TSO Director and other roles. Participation in the program assessment is low; a second round will begin December 3rd, with members encouraged to participate to the maximum extent possible. The in-person portion of

the assessment will take place in February 2026 at the Portland Airport Sheraton (details to follow).

**Marie Dodds** updated the committee: a holiday impaired driving campaign is underway, along with research projects on impaired driving decision-making and technology.

DPSST

In a verbal report for his grant, **David Beatty** shared that over 900 officers were trained in SFST and refresher courses in FY2025.

DMV

**Jonathan Munson** thanked OJD for the opportunity to collaborate with DMV and provide feedback on [updated DUII diversion forms](#), to provide clearer information to those parties affected.

**Kimberly Rose** noted the expected effective date for the new DUII diversion forms: February 1, 2026 (pending Supreme Court approval). [A written report was also provided.](#)

OLCC

**Gary Wilcox** reported current vapor testing (specifically for products purchased online); results will be shared with the Committee later.

OSP DRE

**Sergeant Ryan Clarke** provided updates on training, grants, and the law enforcement phlebotomy program.

OSP HVE

**Lieutenant Logan Denney** noted 31 operations have been completed in this grant year; upcoming operations will be in Portland and Eugene. Preparation is underway for winter chain enforcement.
