Portland Police Traffic notified on May 25th about this fatal. Passed away on 5/25/2023 at 1432hrs.

On Sunday 4/30/2023 East Precinct Officers responded to the scene of a crash on SE Foster Rd at SE 65th Ave. The crash involved a 2022 KIA Soul and a XXX motorcycle.

The investigation revealed the vehicle was Westbound on SE Foster Rd about to turn Southbound on SE 65th Ave. As the vehicle turned left the motorcycle collided into the passenger side of the vehicle. The driver of the vehicle stated they did not see the motorcycle or any lights. It was determined the motorcycle did not have headlights or a license plate.

Witnesses stated the motorcycle had been seen speeding up and down SE Foster Rd at 50-60 MPH

Central Precinct Officers responded to an injury crash at SE Water Ave and SE Yamhill St for a single motorcycle crash.

The investigation determined that motorcycle was traveling Southbound on I5 taking the ramp to Eastbound I84. The motorcycle rider was unable to negotiate the curve on the ramp and collided with the concrete barrier before careening off the ramp and down onto Water Ave below. The vertical drop was over 60 feet.

Reconstructionist worked up the speed of the motorcycle when it left the bridge was 35MPH. It is unknown what the speed of the motorcycle was when it first impacted the concrete barrier.

East Precinct Officers responded to the scene of a crash on SE Stark St at 139th ave. The crash involved a pickup and a motorcycle. The motorcycle operator died at the scene. The motorcycle passenger was thrown from the vehicle and transported to OHSU with serious, but not life threatening injuries. There were no injuries to the pickup driver (identified as Coulter) or passengers.

Based on witness statements and video, the motorcycle was Eastbound on SE Stark at freeway speeds, the pickup was Westbound, turning left (south) on 139th. The motorcycle struck the rear quarter panel of the pickup, behind the rear wheel. The motorcycle was reported stolen 3 weeks ago. The driver of RAM truck cooperated with investigators and showed no signs of impairment.

Reconstructionist told me the speed of the motorcycle prior to impact was 83MPH.

North Precinct Officers responded to the scene of a motorcycle versus SUV crash at NE Columbia Blvd and NE Cully Ave.

The investigation determined the SUV was traveling Westbound and turning Southbound onto NE Cully Ave. The motorcycle was traveling Eastbound. Witnesses stated the motorcycle was traveling at a high rate of speed prior to the collision and the rider was not wearing a helmet.

The driver of the SUV stated he did not see the motorcycle rider prior to the crash.

The motorcycle rider was transported to Emanuel Hospital and died from his injuries the following morning.

Reconstructionist told me the speed prior to impact was high 70's to low 80's.

North Precinct officers responded to the scene of a reported fatal crash on N Marine Drive at Bybee Lake Rd. This area had been taken over by a large number of vehicles and spectators participating in a street racing takeover event. North Officers and a Sergeant responded as a group to the crash scene. They determined the collision involved a Black SUV (vehicle #2) and a blue motorcycle (vehicle #1). Driver #1 was obviously deceased, and likely died on impact. North Precinct officers and sergeants did a good job of securing the crime scene. Only Driver #2 and her passenger remained at the scene. The MCT Sgt was notified and the MCT was paged out.

After North Officers secured Marine Dr, a motorcycle raced through the crash scene. The motorcycle was located and followed by ASU, the driver was eventually arrested in Gresham.

The investigation revealed Driver #2 had been watching the street racing event, but wanted to move to a different viewing location for safety reasons. Driver #2 was westbound on Marine Dr, stopped and preparing to turn left on Bybee Lake Rd. After a group of motorcyclists went by eastbound on Marine Dr, Driver #2 turned left and was struck by vehicle #1. Based on roadway evidence and vehicle damage, speed is the primary factor of the crash.

FED, the Medical Examiner and Command responded to the scene. The DA's office is notified via this email.

This investigation is ongoing.
